What is The Payments Academy?

With great success the past twenty years, The Treasury Institute for Higher Education facilitated the PCI DSS Workshop for Higher Education. The Institute is proud of the efforts and successes made possible by a collaboration of Practitioners, Industry Experts and Supporters. In 2023 we completed the transition from the Institute to the Payments Academy to enable the enhanced mission of assisting Higher Education in broader payment issues while still including PCI DSS training and updates.
