



Rider Agreement

Performance Description

Ninety (90) minute performance including 15 minute intermission.

Compensation

Artist's fee shall be paid in cash, money order or cashier's check. 50% deposit due upon execution of contract. Remaining 50% payment must be made **prior** to Artist's performance.

Transportation/Hotel

Purchaser shall be responsible for booking and paying for 8 double-occupancy rooms at a 4-star or better hotel in close proximity to venue (5 miles or less if possible) or a complete cash buyout.

Tickets/Guestlist

Purchaser shall make available to Artist twelve (12) complimentary tickets for Artist's use for the performance.

Equipment/ Provisions:

Purchaser shall provide Artist with the following equipment:

- Purchaser agrees to provide, at his sole cost and expense, the local sound equipment) for the. Purchaser shall provide competent sound engineer to operate above-mentioned sound equipment.
- Purchaser agrees to provide, at his sole cost and expense the local lighting equipment. Purchaser shall provide competent lighting engineer to operate above-mentioned lighting equipment. Lighting to include: wash colors, 2-4 movers/ static gobos.
- Purchaser agrees to provide a white cyclorama pre-hung prior to arrival to cover the backstage wall.
- Dry ice for fog machine provided 4 hours prior to performance.
- Haze and fog approvals (I.C.E brings special effect equipment)
- Flat level performance stage (if not will need to build one at purchasers expense)
- 4 Clothing racks for side stage
- 10 chairs for side stage
- Suitable quick change areas on side stage
- 4-6 load in and out laborers
- 2 body mics, 1 backup handheld (over ear preferred)
- Ushers to ensure NO flash photography or video/audio recording of any kind
- All current public performance music licensing (ASCAP, BMI, etc)
- Proper load in dock or easily stage accessible door
- Male dressing room, Female dressing room, Production room

Catering

Purchaser shall provide Artist and crew (2) with full meals or cash buyout (\$10/person), as well as ten (10) bottles of water and twenty-four (24) complimentary soda/juice drinks. Meals to include one grazing meal and one hot meal. Grazing meal at arrival and hot meal 3 hours before show.

Merchandising Requirements

Artist shall have the sole right to display and sell merchandise at the performance and retain 85% of the proceeds there from. Purchaser will supply one table in a primary and visible location for sale, for every five hundred people (500) in attendance, and an in house seller that will receive 15% at settlement.

Sound Check

Sound check is mandatory; exact time to be mutually arranged between Purchaser and Artist. If not otherwise agreed upon, Purchaser agrees to provide sound check at least 2 hour prior to performance.

Parking

Purchaser agrees to provide two (2) secure parking spaces for Artist's vehicle(s), and trailer for a period commencing eight (8) hours prior to the performance and continuing for two (2) hours following the performance.

Security

Purchaser agrees to guarantee proper security at all times to ensure the personal safety of the Artist, auxiliary personnel, equipment and personal property, during and after the performance.

Liability

Neither Artist nor Purchaser will be liable for failure to perform under this agreement where the failure is caused by forces beyond the control of Artist or Purchaser, as the case may be. Such forces include without limitation, government actions, illness or disability of Artist, and acts of God including severe weather or natural disasters.
