Each mini-grant awarded will require a match (either in cash or documented in-kind services) from the business and/ or property owner. The typical match is \$1 in match from the business/ property owner for every \$1 provided by DLRP Main Street Arkansas. Each applicant's matching requirements and DLRP Main Street Arkansas funding limits are based on grant availability and project type.

This is a competitive mini-grant application process. Submission of an application does not guarantee an award.
