

## Events - \$2M Insurance Rates

**Includes:** Anniversaries, art shows and exhibits, auctions, banquet, bazaars, adult birthday parties, dance parties, dinners, exhibits, family celebrations to include; christenings, showers, stags, weddings, etc., fashion shows, festival/concert, garage sale for local neighbourhood ONLY at municipal facility, graduation, photo shoots, picnics, theatre performances, music and dance recitals/ performances, retirement, dance and talent shows, reunions. *For family showers, family christenings, family dinners, retirement events and picnics, see "Special Event - Flat Rate" below.* **Excludes:** Bouncy Castles (unless a professional company sets it up, monitors its use, removes it and carries their own insurance), Dunk Tanks, Fireworks (unless under the supervision of a Fireworks supervisor)

### **Frequently Asked Questions**

Q: What if an event is not listed above?

A: If an event is not listed in one of the categories above then send an email to the [PRCSrisk@ottawa.ca](mailto:PRCSrisk@ottawa.ca) mailbox.

Q: I noticed there is a new "Special Event" rate. Can you tell me about it?

A: This is for primarily for family-oriented events such as showers, christenings, dinners etc. The maximum is 100 people. Weddings are not included.

Q: Are bouncy castles ever allowed?

A: Bouncy castles are allowed under certain conditions including: that they are set up, supervised and removed by a professional company. That company must provide proof of insurance for a minimum of \$2M with the event organizer (rental client) and City of Ottawa listed as 'Additional
