### **Encourage Businesses to Post Anti-Trafficking Poster:**

- California Civil Code Section 52.6 requires certain businesses to post a notice that promotes resources available to victims of human trafficking and the community.
- These businesses include:
  - (1) On-sale general public premises licensees under the Alcoholic Beverage Control Act (Division 9 (commencing with Section 23000) of the Business and Professions Code ).
  - (2) Adult or sexually oriented businesses, as defined in subdivision (a) of Section 318.5 of the Penal Code .
  - o (3) Primary airports, as defined in Section 47102(16) of Title 49 of the United States Code.
  - (4) Intercity passenger rail or light rail stations.
  - o (5) Bus stations.
  - (6) Truck stops. For purposes of this section, "truck stop" means a privately owned and operated facility that provides food, fuel, shower or other sanitary facilities, and lawful overnight truck parking.
  - o (7) Emergency rooms within general acute care hospitals.
  - (8) Urgent care centers.
  - o (9) Farm labor contractors, as defined in subdivision (b) of Section 1682 of the Labor Code.
  - o (10) Privately operated job recruitment centers.
  - (11) Roadside rest areas.
  - (12) Businesses or establishments that offer massage or bodywork services for compensation and are not described in paragraph (1) of subdivision (b) of Section 4612 of the Business and Professions Code.
  - (13) Hotels, motels, and bed and breakfast inns, as defined in subdivision (b) of Section 24045.12
    of the Business and Professions Code , not including personal residences.
- Where similar posting requirements have been enacted, there has been an increase in the number of reported human trafficking situations and rescues of victims.
