Waiting List Opening for Mainstream Voucher Targeted Subgroups

Dane County Housing Authority (DCHA) has been awarded funding for vouchers under the Mainstream Voucher Program. Mainstream Vouchers are tenant-based vouchers that serve households that include a person who is at least 18 years old and not yet 62 years old with disabilities as defined in 42 U.S.C. 423. DCHA will be opening its Section 8 Housing Choice Voucher Program waiting list for some of the subgroups DCHA committed to targeting in its application for these vouchers. The waiting list will be open until DCHA receives an adequate number of applications to serve under its Mainstream Voucher funding.

On Tuesday October 6th at 8:30am DCHA will begin accepting applications from the following targeted populations:

1. Families that are currently homeless, eligible for a Mainstream Voucher, and are referred by The Road Home.

- The family must include a person with disabilities who is at least 18 years old and not yet 62 years old.
- The family must be currently homeless and on Dane County's Housing Priority List.
- The family must be referred by The Road Home.
 - The Road Home will only be referring families that meet HUD's definition of Homeless under Category 1 or Category 4.

2. Single individuals that are currently homeless, eligible for a Mainstream Voucher, and are referred by The Salvation Army.

- The individual must be a person with disabilities who is at least 18 years old and not yet 62 years old.
- The individual must be currently homeless and on Dane County's Housing Priority List.
- The individual must be referred by The Salvation Army.
 - The Salvation Army will only be referring individuals that meet HUD's definition of Homeless under Category 1 or Category 4.

3. Families or Single individuals that are at serious risk of institutionalization or are transitioning out of an institutional or other segregated setting, are eligible for a Mainstream Voucher, and are referred by Movin' Out.

- The family/individual must include a person with disabilities who is at least 18 years old and not yet 62 years old.
- The family/individual must be at serious risk of institutionalization OR be transitioning out of an institutional or other segregated setting.
- The family/individual must be referred by Movin' Out.

Only completed applications received from a partnering referral agency will be accepted. If you fall into one of the targeted subgroups listed above, contact the appropriate agency below to work with them to apply.
