### The Google News Initiative Supports Efforts to Increase Audience Engagement for Local Journalism.

The Google News Initiative (GNI) is committed to help journalism thrive in the digital age by offering support to projects that drive digital innovation and develop new business models. The GNI will fund projects from around the world with the intent of producing learnings and thought leadership that can be shared with the wider industry. Projects can be experimental but must be for sites that are already in operation at the time of application and must have measurable, well-defined goals. GNI encourages applicants to clearly underline the opportunities of the project by providing clear key performance indicators (KPIs). KPIs should have a significant digital component. Projects will be evaluated against four main criteria:

- **Impact on the news ecosystem:** Projects should demonstrate potential for significant positive impact on the creation of new revenue streams and/or change the way people consume digital news.
- **Innovation:** Preferred projects will be innovative (use of technology, business model, new reader engagement approaches, etc.) and transformative for the applicant and for users.
- **Feasibility:** Project should demonstrate clear indicators and metrics or even a business plan, when relevant, and set out key risks and mitigation steps.

- **Inspiration:** How can the project help news organizations learn from each other? Willingness to share knowledge, open source code and/or contribute to the improvement of the ecosystem overall.

Grant Amount: Grants of up to \$300,000 are available.

Eligibility: Organizations of every size are eligible for this opportunity, including: digital natives, startups, NGOs, industry organizations, broadcasters, traditional news organizations, freelancers, and sole proprietors - that aim to produce innovative, original journalism and to enlighten citizens with trustworthy journalistic content, and whose projects focus on encouraging a more sustainable news ecosystem. Organizations must be incorporated or based in the United States, Canada, or the United States Oversees Territories.

**The Andy Warhol Foundation Funds Institutions Supporting Artists.**

The Andy Warhol Foundation focuses on serving the needs of artists by funding the institutions that support them. Grants are made for scholarly exhibitions at museums; curatorial research; visual arts programming at artist-centered organizations; artist residencies and commissions; arts writing; and efforts to promote the health, welfare and first amendment rights of artists. Grants are made on a project basis to curatorial programs at museums, artists' organizations, and other cultural institutions to originate innovative and scholarly presentations of contemporary visual arts. Projects may include exhibitions, catalogues, and other organizational activities directly related to these areas. The program also supports the creation of new work through re-granting initiatives and artist-in-residence programs. The Foundation values the contributions of all artists, reflecting the true diversity of the contemporary art field, and encourages proposals that highlight women, artists of color, and under-represented practitioners. Grants are also made to support efforts to strengthen areas that directly affect the context in which artists work.

Grant Amount: Grant amounts not specified.

Eligibility: Eligible organizations are limited to nonprofits in the United States with 501(c)(3) status.

**NEW!!****The Americana Foundation Supports Preservation, Acquisition, and Restoration Projects for Handcrafted Furniture and Heritage Buildings.**

The Americana Foundation supports preservation and restoration projects for handcrafted furniture and heritage buildings. The Americana Foundation seeks to promote knowledge, preservation, and accessibility of America's heritage through increasing educational opportunities of future conservators and curators in the field and through preservation and presentation of unique collections.

Projects considered for grants include:

- Preservation and/or acquisition of high style, classic, handcrafted furniture from the 18th and 19th centuries as well as supporting their placement with charitable and educational institutions, and/or the US government.
- Career development support for curatorial and conservation internships within major institutions and universities.
- Restoration projects for heritage buildings and cultural landscapes that are listed or eligible for listing in the National Register of historic places.

Given limited funds and its commitment to collaboration, the Foundation is most interested in requests that are supported by multiple sources, sustainable over time, and for a single year only.

Grant Amount: Grant amounts not specified.

Eligibility: The Foundation makes grants only to nonprofit organizations that have been determined by the IRS to be charitable, scientific or educational and have been recognized under Section 501(c)(3) of the IRS Code to be tax exempt and not a private foundation.

**NEW!!****The Pollock-Krasner Foundation Accepting Grant Applications from Artists Experiencing Financial Hardship.**

The Pollock-Krasner Foundation is accepting grant applications from artists experiencing financial hardship. The Foundation welcomes applications from visual artists who are painters, sculptors, and artists working on paper, including printmakers. Applications are encouraged from artists who have genuine financial needs that are not necessarily catastrophic. Grants are intended for a one-year period of time and can be used by the applicant for all legitimate expenditures relating to his or her professional work and personal living (including medical) expenses.

Grant Amount: Grants amounts range from \$10,000 to \$45,000.

Eligibility: The Foundation's dual criteria for grants are recognizable artistic merit and financial need, whether professional, personal or both. Artists must be actively exhibiting their current work in a professional artistic venue such as a gallery or museum.

The Foundation does not accept applications from commercial artists, video artists, performance artists, filmmakers, crafts-makers, computer artists, or any artist whose work primarily falls into these categories. In addition, it does not make grants to students or for academic study or to pay for past debts, legal fees, the purchase of real estate, moves to other cities, personal travel, or to pay for the costs of installations, commissions, or projects ordered by others.

Due Date: Applications are accepted on an ongoing basis.

#### **Terra Foundation Announces Relief Funds for Visual Arts Organizations.**

The Terra Foundation seeks to provide immediate relief to visual arts organizations who have been financially impacted by COVID-19. The fund provides emergency support to arts organizations, as well as relief over the next two years for arts organizations in the United States. Grants will be awarded in two phases, an initial emergency response for immediate release to pre-selected organizations that are part of the foundation's network of partners, and an ongoing relief effort for US museums.

The first round of emergency relief funding is for up to \$4 million to support partners, including:

- \$2.6 million to support operating costs awarded directly to US museum partners and nationwide arts service organizations.
- \$400,000 to support operating costs awarded directly to selected international museums that have been ongoing, multi-year foundation partners.

The second round of relief funding is for up to \$4 million, awarded over the next two years. The grants will include funding for:

- A new responsive grant program for US museums to provide grants to support collection-based projects and exhibitions on American art. Application details will be announced in the summer of 2020.

Grant Amount: Individual grants of up to \$150,000 are available.

Eligibility: Domestic and international arts organizations are encouraged to apply.

Due Date: Grant applications will be accepted on an ongoing basis.

**Andrew W. Mellon Foundation Supports Collection and Preservation of Artistic Expression.**

The Andrew W. Mellon Foundation supports the creation, collection, and preservation of artistic expression. The Arts and Cultural Heritage program seeks to nurture exceptional creative accomplishment, scholarship, and conservation practices in the arts while promoting a diverse and sustainable ecosystem for these disciplines. The program supports the work of outstanding artists, curators, conservators, and scholars, and endeavors to strengthen performing arts organizations, art museums, research institutes, and conservation centers. The Foundation will support:

- Programs that strengthen the creation and preservation of, as well as scholarship about, new media and multidisciplinary arts
- Initiatives that broaden public access to and understanding of the arts
- Research, training, and recruitment programs that enhance diversity and inclusion in arts organizations
- Collaborations between institutions of higher education and the arts
- Efforts to address vulnerabilities distinctive to the arts, such as the financial health of small arts organizations and emergency preparedness and response

Grant Amount: Grants of up to \$150,000 are available.

Eligibility: Nonprofit and private arts organizations are encouraged to apply.

Due Date: Grant applications are reviewed every quarter.

**GKV Foundation Supports Arts Organizations with “Big Ideas”.**

The objective of the GKV Foundation is to support individual development and related community impact through the use of a range of artistic media such as the visual arts, music, and dance. The targeted programs will be on the wish lists of established not-for-profits; big ideas with great potential but as of yet, unfunded and, by consequence, untested. The goal is that with GKV first-year funding enough measurable results will be achieved to attract sustaining funding from other sources.

Grant Amount: Grants range from \$15,000 to \$50,000.

Eligibility: Eligibility is limited to nonprofit organizations with 501(c)(3) status with the IRS.

## **The Alliance for California Traditional Arts Accepting Applications for the Living Cultures Grants Program for Small Budget Organizations.**

The Alliance for California Traditional Arts, via the Living Cultures Grants Program, seeks to sustain and strengthen the folk and traditional arts in the state of California. This program funds pathways to nurture, sustain, and engage participation in traditional arts, including the following:

- Workshops and gatherings (for example, events that bring together artists, cultural specialists or community leaders to share skills & information, or to engage in discussion and problem-solving)
- Conservation, creation, or acquisition of important traditional art items
- Intergenerational classes or other educational programs within a community (after school youth programs, dance ensemble classes or practices, summer programs, etc.)
- Other kinds of mentorships with culture bearers, honoraria, travel costs within CA, etc. (intensive one-on-one artistic mentorships should apply to the Apprenticeship Program rather than the Living Cultures Grants Program)
- Endangered language conservation and revitalization projects when carried out within the context of traditional art forms
- Other types of activities and projects that lead to cultural continuity of traditional art practices
- Sustaining future traditional art practices with needed purchases, services, or acquiring new skills
- Equipment and materials purchases (instruments, media equipment, costumes or regalia, etc.)
- Documentation of traditional arts, skills, ceremonies, beliefs, or performances • An investment to result in future revenues (fee for services for marketing consultation, website development, financial planning )
- Learning new skills by supporting mentorships with advisors or cultural specialists
- Public presentations, such as community-based concerts, festivals, and exhibitions that foster active participation
- Other types of activities and projects that lead to active participation in traditional art practices within and between cultural communities

The program will not fund:

- General operating support
- Projects whose main purpose is fundraising
- Projects limited to a historical emphasis, including events presenting the re-creation of past lifestyles
- Projects based on the interpretation of a cultural tradition, instead of the actual tradition or cultural art form itself
- Projects based in educational institutions (K-12, private schools and universities), such as folk arts-in-education projects, university seminars, and programs, or curriculum development
- Out-of-state travel

- More than one proposal per organization (except for fiscal sponsors applying on behalf of more than one organization)
- Proposals for multiple components of the same festival, event, or project

Grant Amount: Grants of up to \$5,000 are available.

Eligibility: Only California-based 501 (c) 3 non-profit organizations are eligible. Communities who do not have this status may work through a California-based non-profit fiscal sponsor. Applicants must have an organizational budget under \$250,000 per year. Additionally, current grantees of the William and Flora Hewlett Foundation are not eligible and current grantees of the Creative Work Fund may not receive an ACTA Living Cultures Grant for the same project.

#### **PEN America Announces Emergency Funding to Support Writers Impacted by COVID-19 Crisis.**

PEN America is expanding its long-standing Writers' Emergency Fund as part of the efforts to support the literary community at a time when the health and livelihoods of so many are at risk. The Writers' Emergency Fund is intended to assist fiction and non-fiction authors, poets, playwrights, screenwriters, translators, and journalists.

Grant Amount: Grants range from \$500 to \$1,000.

Eligibility: To be eligible, applicants must be based in the United States, be a professional writer, and be able to demonstrate that this one-time grant will be meaningful in helping them to address an emergency.

Due Date: Applications will be accepted on an ongoing basis.

#### **Pulitzer Center on Crisis Reporting Seeking Proposals for Collaborative Approaches to Reporting on Coronavirus.**

The Pulitzer Center on Crisis Reporting, a non-profit organization that supports independent global journalism, is seeking proposals for innovative approaches to reporting on the novel coronavirus crisis using collaboration among journalists and newsrooms across state lines or national borders. The Center is seeking strong proposals that involve a strategic and concerted effort by multiple journalists and/or newsrooms to pursue a reporting project together, leveraging resources, expertise, and publication platforms. In addition to a strong collaboration component for reporting and publication, proposals are encouraged to:

- Focus on systemic, under-reported issues underlying the coronavirus crisis
- Use data-driven and/or interdisciplinary approaches to reporting on coronavirus

- Hold the powerful accountable

Grant Amount: Grant amounts range from \$5,000 to \$10,000.

Eligibility: This opportunity is open to all newsrooms and independent journalists in the United States and abroad.

Due Date: Applications accepted on an ongoing basis.

### **Artist Relief Fund Announces Support for Artists Experiencing Financial Hardship as a Result of COVID-19.**

To support artists during the COVID-19 crisis, a coalition of national arts grantmakers have come together to create an emergency initiative to offer financial and informational resources to artists across the United States. Practicing artists able to demonstrate a sustained commitment to their work, careers, and a public audience who are experiencing dire financial emergencies due to the COVID-19 pandemic are encouraged to apply for financial support through the Artist Relief Fund.

Grant Amount: Grants of \$5,000 are available.

Eligibility: To be eligible, applicants must be practicing artists based in the United States with a Tax ID who can demonstrate financial hardship due to the COVID-19 pandemic.

### **Foundation for Contemporary Arts Accepting Applications for COVID-19 Fund Emergency Grants.**

The Foundation for Contemporary Arts (FCA) is accepting applications from artists in the United States who have been financially impacted by COVID-19 for the COVID-19 Fund Emergency Grants program. In response to the COVID-19 pandemic, FCA has created a temporary fund to meet the needs of experimental artists who have been impacted by the economic fallout from postponed or canceled performances and exhibitions. Relief will be provided to artists who can demonstrate that they have had an engagement canceled or postponed due to the COVID-19 pandemic.

Grant Amount: One-time grants of \$1,500 are available.

Eligibility: Applicants must be living and working in the United States or territories and have a U.S. Tax ID number (SSN, EIN, ITIN, or other).

Due Date: Applications will be reviewed on an ongoing basis until August 31, 2020.

**The Lovett Foundation Supports Theater by Elementary School Students in a School Drama Program.**

The Charlie Lovett Fund for Elementary Drama is a philanthropic fund that supports production-based theatre arts programs at the elementary school level. Each year, Charlie Lovett donates a portion of the royalties on his plays published by Pioneer Drama, Inc. to the fund, and that donation is matched by The Lovett Foundation. Grants are then made to elementary schools throughout the United States.

Grant Amount: Grants range from \$2,000 to \$3,000.

Eligibility: American elementary schools with tax-exempt status from the IRS as 501(c)(3) are eligible to apply.

**The Kurt Weill Foundation Supports Performances of Works by Composers Kurt Weill and Marc Blitzstein.**

The Kurt Weill Foundation for Music offers support for performances of musical works by composers Kurt Weill and/or Marc Blitzstein. The Foundation awards grants to individuals and nonprofit organizations for performances of musical works by Weill and Blitzstein; for scholarly research pertaining to Weill, Lenya, Marc Blitzstein; and for relevant educational initiatives.

To be eligible, applicants should consider the following criteria:

- The quality of the project and potential for excellence;
- Evidence of the applicant's prior record of achievement, commitment, and ability to carry out the project successfully;
- The potential reach of the project;
- The potential impact of a stage or concert presentation of a work by Kurt Weill or Marc Blitzstein to advance the understanding and appreciation of their works in the performing arts field;
- Capacity to complete the project; and
- The relevance of the project to the furtherance of The Kurt Weill Foundation's goals and current priorities.

Grant Amount: Grant amounts not specified.

Eligibility: Funding may be requested by professional opera companies, theater companies, dance companies, and concert groups for performances of musical works by Kurt Weill and/or Marc Blitzstein. All works must be presented in their authorized versions and orchestrations. Musical adaptations are not eligible for funding.

**The Kress Foundation Accepting Proposals from Organizations Supporting European Art and Architecture.** The Kress Foundation is accepting proposals for its History of Art grant program which provides support to organizations that work to enhance the appreciation and understanding of European art and architecture. The Foundation supports scholarly projects that promote the appreciation, interpretation, preservation, study, and teaching of European art from antiquity to the early 19th century.

Grants are awarded to projects that create and disseminate specialized knowledge, including archival projects, as well as for the development and dissemination of scholarly databases, documentation projects, museum exhibitions and publications, photographic campaigns, scholarly catalogs and publications, and technical and scientific studies. The program also supports activities that permit art historians to share their expertise through international exchanges, professional meetings, conferences, symposia, consultations, the presentation of research, and other professional events.

Grant Amount: Grant amounts range from \$1,000 to \$100,000.

Eligibility: To be eligible, nonprofit organizations, including supporting foundations of European institutions, must be recognized as tax-exempt under Section 501(c)(3) of the Internal Revenue Code.

**The California Arts Council and the National Arts and Disability Center Accepting Applications for Accessible Arts Programs.**

The California Arts Council and the National Arts and Disability Center have partnered to provide small grants to arts organizations seeking to make their programs accessible for all. California-based arts organizations may request small grants to support the hiring or involvement of artists with disabilities in arts events, and/or to increase the attendance and enhance the experience for audiences with disabilities.

Sample projects included:

- Services and supports to hire California artists with disabilities
- Increased access for audience members with disabilities to enjoy the full experience by creating alternative formats for materials such as large print or Braille, audio description, ASL interpreter, and/or captioning
- Attendance at meetings, workshops, and trainings that address accessibility
- Hiring a consultant to advise or provide training to improve the accessibility of the organization or its programs

Grant Amount: Grants of up to \$2,500 are available.

Eligibility: Eligible applicants must be:

- A California-based nonprofit arts organization with a history of arts programming for a minimum of three years prior to the time of application
- Local arts agency or unit of government with a history of arts programming for a minimum of three years prior to the time of application
- The applicant must demonstrate proof of nonprofit status under section 501(c)(3) of the Internal Revenue Code, or section 23701d of the California Revenue and Taxation Code, or must be a unit of government
- An applicant without nonprofit status may use a California-based fiscal sponsor that has nonprofit status, 501(c)(3)

Due Date: Applications are accepted on an ongoing basis until funds are exhausted. Applications must be received at least 30 days prior to a proposed event.

**America's Healthy Food Financing Initiative Supports Efforts to Improve Access to Healthy Food in Underserved Communities.**

The purpose of America's Healthy Food Financing Initiative (HFFI) is to improve access to healthy food in underserved areas, to create and preserve quality jobs, and to revitalize low-income communities by providing financial and technical assistance to eligible fresh, healthy food retailers and enterprises to overcome the higher costs and initial barriers to entry in underserved areas. As such, HFFI has created the Targeted Small Grants (TSG) program. The TSG program offers financial assistance in the form of grants to eligible fresh, healthy food retailers and enterprises.

The TSG program supports innovative fresh food retail and food system enterprises that seek to improve access to healthy food in underserved areas through food retail. Grants could assist projects with a variety of aspects of project development, renovation, and/or expansion. Grants are designed to be one-time investments of capital into a food retail or food enterprise project in order to address higher costs and initial barriers to entry in underserved rural and urban areas. Grant funds should unlock additional sources of capital, catalyze project sustainability, meet financing gaps, and/or enable deeper impact or project reach. In conjunction with the TSG program, Reinvestment Fund will also provide Technical Assistance (TA) to support selected early stage projects where resources would help build local capacity to develop a food retail outlet or enterprise and would clarify or advance an eligible project.

Grant Amount: Grants ranging from \$20,000 to \$200,000 are available.

Eligibility: Eligible applicants include for-profit business enterprises, cooperatively owned businesses, tax-exempt nonprofit corporations, institutions of higher education, state and local government agencies, and tribal government agencies.

Due Date: Letters of Interest must be submitted by July 10, 2020. Eligible applicants will be invited to submit a full application upon review.

**The Domanica Foundation Supports Programs to Alleviate Poverty.**

The Domanica Foundation supports programs to alleviate poverty and social programs that enhance and enrich lives and foster empowerment and respect. The foundation invests in the following activities:

Organizations interested in applying should submit a Proposal Summary including a description of the organization's goals, leadership, partners, clients, funding sources, and financial requirements, in addition to a brief summary of the project proposal and its budget.

Grant Amount: Grant amounts not specified.

Eligibility: Eligible applicants include organizations with 501(c)(3) tax-exempt status.

Due Date: Proposal summaries are accepted on an ongoing basis.

### **The Global Fund for Children Supports Programs that Improve the Lives of Vulnerable Children and Youth.**

The Global Fund for Children supports organizations creating sustainable improvement in the lives of vulnerable children and youth. Organizations should also serve as a resource or model for other organizations. Organizations and grantee partners must focus on the most vulnerable populations, or the children of “the last mile”—those who are economically and socially outside the reach of mainstream services and support, including street children, child laborers, AIDS orphans, sex workers, hard-to-reach rural populations, and other vulnerable or marginalized groups. Priority will be given to organizations that engage children and youth as active participants in their own growth and development, rather than as passive recipients of services. Organizations are selected based on the following criteria:

- **Appropriate size and stage of development:** Prospective grantee partner’s annual budget should not exceed \$200,000. In most cases, new grantee partners have budgets in the \$25,000 to \$75,000 range. The aim is to identify organizations at a relatively early stage of development.
- **Direct involvement with children and youth:** Prospective grantee partners must work directly with children and youth. Foundation does not support groups engaged exclusively in advocacy or research.
- **Capable management:** Grantee partners must have systems and processes for ensuring responsible management of funds. At a minimum, an organization must have basic accounting and reporting systems as well as phone and email access.
- **Local Leadership:** Grantee partners must be led by individuals who live and work in the community. Organizations whose leaders were born and raised in the community they serve are prioritized.

Grant Amount: Grant amounts not specified.

Eligibility: All applicant organizations or sponsoring agencies must be exempt from federal taxation under the Internal Revenue Code Section 501(c)(3). If the political context makes legal registration unfeasible, the organization must demonstrate nonprofit equivalency. There is no start-up funding for the creation of a new organization.

Due Date: Organizations can submit an organizational profile at any time. Those who meet the criteria will be invited to submit a full proposal.

### **Solutions Project Announces Rapid Response Grants to Support Women and Leaders of Color in Regenerative Economic Initiatives.**

The Solutions Project, through the Fighter Fund, provides rapid response grants in real-time to support frontline leaders that shift culture and narrative to achieve a just transition towards a regenerative economy in the United States. Resources are designed to support place-based moments through organizing, direct action, advocacy, and lobbying activities; communications that build public will and cultural power; inclusive coalition building efforts; and frontline models of innovation.

5. Community-led demonstration projects in need of seed capital advancing models of innovation in clean energy, water, food and other areas advancing a Just Transition.

Successful applications must have a cultural power building component that leverages strong narrative and storytelling opportunities.

Grant Amount: Grant amounts typically range from \$10,000 to \$30,000.

- E. The Foundation does not support cases where the relief sought is for an individual except if it would involve an important legal precedent addressing a systemic issue.
- F. The Foundation does not support criminal cases where an individual is charged with a crime.
- G. The Foundation will not award a grant where an organization is seeking general support for its mission.
- H. Successful grant applicants can be considered for grants in subsequent years based upon the results of the grantee's efforts in the prior year.

Consideration of grants will be rated and based upon (1) Alignment with the Foundation's Mission, (2) Quality of the Proposed Project, (3) Capacity of the Organization to Carry Out the Proposed Project, (4) Urgency of the Proposed Project, and (5) Financial Health and Stability of the Applicant Organization.

**American Humane Supports Medical Procedures for Animals that Have Been Victims of Neglect or Abuse.**

Through the Second Chance Fund, American Humane supports medical procedures for animals that have been the victims of abuse or neglect and require medical treatment before being placed for adoption. Routine medical procedures—such as vaccinations, heartworm testing, behavior modification, and/or training are outside the scope of this fund. Spay/neuter surgery costs, if listed in the itemized costs of care for a cruelty/neglect case, even if not medically necessary for treatment, are eligible. Medical procedures covered under the fund should allow animals to medically recover and live a relatively pain-free life and be successfully placed in new homes. Applications must be received no later than six months following the date of intake of the animal(s). Due to the overwhelming number of abuse cases nationwide, the Second Chance Fund is offered only in select cases of animal abuse or neglect. Funding is awarded on a case-by-case basis. Selected cases will be used for fundraising purposes.

Grant Amount: Funding to any one agency is limited to \$2,000 per fiscal year.

Eligibility: 501(c)(3) animal sheltering agencies (public or private) and rescue groups are considered for the Second Chance Fund.

To apply to participate in L4G's co-funded grant process, nonprofits must be nominated by one of their current funders (existing or new). L4G is focused on applying a semi-standard survey instrument, which includes using the Net Promoter System employed widely in customer feedback circles, to the nonprofit beneficiary context. The core feedback tool is a simple survey consisting of five standard questions that all participating L4G organizations are required to ask:

1. How likely is it that you would recommend [...] to a friend or family member?
2. What is [...] good at?
3. What could [...] do better?
4. How much of a positive difference has [...] made in your life?
5. How often do staff at [...] treat you with respect?

In addition, organizations can ask four optional demographic questions and add up to five custom questions to their survey. The quantitative and qualitative responses to the L4G survey are gathered using a variety of data collection methods — including kiosks, tablets, paper surveys, and in-person interviews — adapted in multiple languages, when appropriate. The survey-platform provider, SurveyMonkey, provides benchmarks to compare organizations' responses to those of organizations in similar issue areas. The fund also provides high-quality technical assistance to help organizations collect, interpret, and respond to feedback.

Grant Amount: Eighteen-month grants of \$30,000 as well as access to technical assistance are available.

**Office on Violence Against Women Announces Funds to Support National Tribal Clearinghouse on Sexual Assault.**

The Office on Violence Against Women (OVW) announces funding for a national clearinghouse to provide training and technical assistance on issues related to sexual assault of American Indian and Alaska Native (AI/AN) women, designed to improve victim services for criminal and civil justice responses to AI/AN sexual assault victims as well as increase offender accountability for such crimes. The National Tribal Clearinghouse on Sexual Assault funding may be used to establish, sustain, and/or expand training, educational programs, and technical assistance (TA) on issues relating to sexual assault of AI/AN women. Funding priority will be given to applicants proposing innovative ways of reaching a national audience of entities addressing the sexual assault of AI/AN women, including tribal governments, tribal victim service providers, and tribal and non-tribal organizations within urban areas.

Grant Amount: Grants range from \$250,000 to \$500,000.

Eligibility: Eligibility is limited to private institutions of higher education, nonprofits that do not have a 501(c)(3) status with the IRS, nonprofits having a 501(c)(3) status with the IRS, Native American

tribal organizations (other than Federally recognized tribal governments), and public and State controlled institutions of higher education.

**Administration for Children and Families Announces Funds Available to Operate National Human Trafficking Hotline.**

The Administration for Children and Families (ACF) announces funds to operate the National Human Trafficking Hotline (NHTH). The goal of the NHTH is to maintain and support the operation of the current hotline, which includes telephone, text, chat, and website capabilities that provide coverage in the United States (U.S.) and U.S. territories. The NHTH is a toll-free hotline that operates 24 hours a day, every day of the year. Trained, experienced human trafficking advocates provide services and assistance through the NHTH to victims of severe forms of human trafficking. Under the NHTH, the following activities are required:

- Operate the NHTH, a 24/7 U.S. National Hotline that receives signals through telephone, text, chat, and website;

- Promote NHTH services to increase the identification and protection of victims of severe forms of human trafficking;
- Provide information and service referrals to victims of human trafficking using a trauma-informed, person-centered, culturally responsive, and linguistically appropriate approach in a timely manner; and
- Notify law enforcement agencies of potential cases of human trafficking, as well as instances when a trafficking victim is in imminent danger, and document emerging trafficking schemes to assist in the detection and investigation of trafficking cases.

Grant Amount: Grant amounts not specified.

Eligibility: Eligible applicants include state governments; county governments; city or township governments; special district governments; independent school districts; public and state-controlled institutions of higher education; Native American tribal governments (federally recognized); public housing authorities/Indian housing authorities; Native American tribal organizations (other than Federally recognized tribal governments); nonprofits having a 501(c)(3) status with the IRS other than institutions of higher education; private institutions of higher education; for-profit organizations other than small businesses; and small businesses.

**Office on Trafficking in Persons Announces Funds for Human Trafficking Youth Prevention Education.** The Office on Trafficking in Persons (OTIP) is announcing funds for the Human Trafficking Youth Prevention Education (HTYPE) Demonstration Program. The goal of the HTYPE Demonstration Program is to fund local educational agencies (LEA) to develop and implement programs to prevent human trafficking victimization through the provision of skills-based human trafficking training and education for school staff and students as specified in the Frederick Douglass Trafficking Victims Prevention and Protection Reauthorization Act of 2018. Under the HTYPE Demonstration Program, the following activities are required:

- Provide human trafficking education that equips educators and other staff to identify and respond to signs that students are at high risk of or are currently experiencing human trafficking
- Deliver student human trafficking prevention education that is designed to build student resilience to labor trafficking and sex trafficking by strengthening student knowledge and skills
- Train qualified individuals to implement and replicate project activities throughout the school district or identified target area(s)

- Establish and implement a Human Trafficking School Safety Protocol (HTSSP). The LEA must work in partnership with a nonprofit or nongovernmental organization (NGO) to provide all aspects of human trafficking prevention education to students and school staff.

The LEA will consult with local law enforcement in the development of the HTSSP, specifically to address the safety, security, and well-being of staff and students and to define the proper and effective role of school staff in responding to potential and confirmed cases of human trafficking, including notifying and engaging parents, guardians, or caregivers, as appropriate.

Grant Amount: Grants range between \$400,000 to \$600,000.

Eligibility: Eligibility is limited to local educational agencies.

**U.S. Department of Agriculture Rural Development Supports Distanced Learning and Telemedicine in Rural Communities.**

The U.S. Department of Agriculture Rural Development announces funding available through the Distanced Learning and Telemedicine grant program. The Distance Learning and Telemedicine program helps rural communities use the unique capabilities of telecommunications to connect to each other and to the world, overcoming the effects of remoteness and low population density. This grant program helps rural communities with populations of 20,000 or less acquire the technology and training necessary to connect educational and medical professionals with the teachers and medical providers who serve rural residents at the local level. For example, this program can link teachers and medical service providers in one area to students and patients in another. Grant funds may be used for:

- Acquisition of eligible capital assets, such as:
  - Broadband transmission facilities
  - Audio, video and interactive video equipment
  - Terminal and data terminal equipment
  - Computer hardware, network components and software
  - Inside wiring and similar infrastructure that further DLT services
- Acquisition of instructional programming that is a capital asset
- Acquisition of technical assistance and instruction for using eligible equipment

Grant Amount: Grants starting at \$50,000 are available.

Eligibility: Eligible applicants include most entities that provide education or health care through telecommunications, including: state and local government agencies, federally-recognized tribes, non-profit organizations, for-profit businesses, and consortia of eligible entities.

### **Health Resources and Services Administration Supports Rural Opioid Response Innovations.**

The Health Resources and Services Administration (HRSA) announces the opportunity to apply for funding under the Rural Communities Opioid Response Program – Planning (RCORP-Planning). RCORP-Planning will advance RCORP's overall goal by strengthening and expanding the capacity of rural communities to provide SUD/OUD prevention, treatment, and recovery services. The purpose of RCORP-Planning is to strengthen and expand the capacity of rural communities to engage high-risk populations and provide SUD/OUD prevention, treatment, and recovery services. Recipients will conduct planning activities, engage multi-sector consortiums, and participate in the RCORP-Planning learning collaborative. While the primary focus of RCORP-Planning is OUD, HRSA recognizes that many individuals with OUD are polysubstance users. Therefore, applicants may also choose to address an additional substance of concern in the target population. RCORP-Planning funds will support 18 months of planning activities.

For this grant, planning activities are those that prepare a community to provide direct prevention, treatment, and recovery services. In addition to the required core planning activities (see Section IV.2, “Program Specific Instructions” for additional details), examples include (but are not limited to):

- Distributing naloxone to individuals/organizations who may need it;
- Providing community-based naloxone trainings;
- Recruiting and training providers and support staff in medication-assisted treatment (NOTE: These grant funds cannot be used to pay providers/support staff to deliver medication-assisted treatment);
- Creating a strategy to reach and engage individuals at high risk of SUD/OUD;
- Working with law enforcement to develop a diversion program;
- Training providers, administrative staff, and other relevant stakeholders to optimize reimbursement for treatment encounters through proper coding and billing.

Direct services may not be provided using these grant funds. Examples of direct services include (but are not limited to):

- Providing Medication-Assisted Treatment
- Providing peer-based recovery services
- Transporting individuals to receive treatment

- Paying individuals to administer naloxone.

Grant Amount: Grant amounts not specified.

Eligibility: Eligible applicants include all domestic public or private, non-profit or for-profit entities, including faith-based and community-based organizations, tribes, tribal organizations, and organizations based in the territories and freely associated states. To be eligible, you must serve rural communities at the highest risk for substance use disorder.

**Bureau of Land Management Supports Youth Conservation Opportunities on Public Lands.**

The Bureau of Land Management (BLM) announces funds to support youth conservation projects on public lands throughout the United States. This opportunity is open to any qualified youth conservation corps established by a state or local government, by the governing body of any Indian tribe, or by a qualified nonprofit organization interested in working cooperatively with the BLM to develop and administer multiple-use conservation projects. Conservation projects must focus on providing employment, education, and public-service opportunities for U.S. citizens and legal residents (between ages 16 and 30 inclusive and veterans up to age 35 inclusive) recruited from local and surrounding communities to assist with projects on public lands. The focused projects may be organized as crews in which participants work collectively and intensely together under supervision of trained and experienced crew leaders or conservation professionals; or organized as individuals or small teams working on specific individual tasks requiring dedicated attention; or projects may be organized in both formats.

Grant Amount: Grant amounts range from \$5,000 to \$400,000.

Eligibility: Any qualified youth conservation corps established by a state or local government, by the governing body of any Indian tribe, or by a qualified nonprofit organization interested in working cooperatively with the BLM to develop and administer multiple-use conservation projects is eligible to apply.
