Contributions are not deductible for federal income tax purposes. An individual may not contribute more than a total of \$2,800 designated to the general election. A couple may contribute up to \$5,600 from a joint account. A multi-candidate federal PAC may contribute up to \$5,000 designated to the general election. Federal election law prohibits contributions from the general treasury funds of a corporation, labor organization or national bank, from any person contributing another's funds, from a federal government contractor or from a foreign national who lacks permanent resident status.
