



# ORIGINAL TAEKWON-DO FEDERATION OF AMERICA PARTICIPANT INFORMATION AND LIABILITY WAIVER AND RELEASE FORM

## Permission to Enroll/Permission to Treat

By reading and agreeing to this form, I hereby give permission for the Named Registrant to participate at the 143<sup>rd</sup> ITF International Instructor Course (IIC), hosted by the Original Taekwon-do Federation of America (OTFA), June 21-23, 2019 in Las Vegas, Nevada.

I acknowledge that despite the best efforts of the representatives of the OTFA, injuries can and do happen in the practice of and training in martial arts, therefore I hereby give the OTFA and its representatives permission to treat in case of injury.

This permission includes calling for transportation to a medical professional for care, consent to treatment by a medical professional contacted in case of a need for care, and includes my assumption of all liabilities and expenses arising out of such injuries. I further agree to hold harmless and indemnify OTFA and its representatives for any medical fees or expenses incurred in this regard.

## Liability Waiver

I understand and agree that participating in a martial arts program and related activities involves certain inherent risks and can be dangerous and that minor or, although rare, serious or life-threatening injuries can occur despite the fact that reasonable safety precautions are taken. I certify that I am physically fit to participate in this type of activity and that I do not have any physical limitations, medical ailments, physical or mental disabilities which would limit or prohibit my participation in the said program or activities.

In consideration for the services offered to me and/or my child by the OTFA; I hereby agree to WAIVE, RELEASE, and FOREVER DISCHARGE the OTFA, its officers, board members, instructors and guest instructors, fellow students and participants, employees, affiliates, agents and representatives, and their respective representatives, heirs, successors and assigns from any and all actions, claims, liability, and demands based upon, arising out of, or by reason of any damage, loss, injury to person or property (no matter how serious) which may have been sustained in the course of or in connection with my and/or my child's training or participation in the above named event.

I also agree that this Waiver and Release shall extend to the owners and/or lessors of the building or property where the 143<sup>rd</sup> ITF International Instructor Course (IIC) on June 21-23, 2019 will be held, and to all sponsors and hosts of the event. I further agree to indemnify and hold harmless the OTFA, including court costs and attorney fees directly or indirectly arising from any action or other proceeding brought by or prosecuted for my benefit contrary to this agreement.

I have read this Agreement and Waiver, and by agreeing, I indicate my understanding and acknowledgement of its terms. I understand that I am giving up substantial rights by agreeing to it, and I agree to it freely and voluntarily without any inducement. If I am agreeing to this document on behalf of a minor child, I have discussed this matter with the child and he or she is aware of the terms of this agreement and agrees to it as well.
