CAL FIRE Local 2881®

What is a trademark? According to the USPTO (United States Patent and Trademark Office), a trademark can be described as a word, phrase, symbol, design, or a combination thereof, that identifies and distinguishes the source of the goods of one party from those of others. The Local 2881 Trademark Committee is tasked with maintaining, protecting, and enforcing our trademarks, but also with finding and selecting vendors whom you buy your CAL FIRE gear from, ensuring the quality of what is sold, and accounting for royalties.

Besides policing and protecting the CAL FIRE Local 2881 and CAL FIRE marks, the Trademark Committee is tasked with the uniform vendor selection process. Our "vendors" supply CAL FIRE and Local 2881 branded products, on and off-duty apparel, and accessories. Currently, the authorized vendors are:

- 1. 2 Hot Activewear & Uniforms. Located in Murrieta and online.
- 2. **Bare Bones Workwear.** Located in Sacramento, West Sacramento, Rancho Cordova, Auburn, Rocklin, Yuba City, Woodland, and online.
- 3. **Distinctive Recognition.** Located in Sacramento and <u>online</u>.
- 4. **Down Range.** Located in Chico and online.

Down Range is the newest vendor selected during our "Request for Proposal (RFP)" Process, which most recently took place in May 2021. Every two years, the RFP process opens, and your Trademark Committee is tasked with viewing numerous submissions from prospective candidates. The Trademark Committee must evaluate the quality and variety of the proposed product line, the vendor's customer service policy, economical pricing, and many other elements to ensure the vendor(s) chosen will live up to the high quality and standards set by the Committee. The Committee has such high standards because it wants to guarantee you, the member, will be satisfied with your purchase. The RFP process can take up to six months from start to finish! The Trademark Committee's perseverance throughout the process is astounding, as it is not a simple task to undertake.

How do your purchases make a difference? Every time you purchase CAL FIRE marked duty gear or off-duty CAL FIRE or CAL FIRE Local 2881 marked apparel or accessories, the Union receives 5% in trademark royalties.

The Union then disburses the entire royalty profit to two amazing philanthropic organizations - the CAL FIRE Benevolent Foundation and the R.J. Ernest Scholarship Foundation. Last year, over \$68,000 in royalties were collected and distributed amongst the two foundations.

The CAL FIRE Benevolent Foundation provides financial assistance for the public good by participating with burn centers and providing disaster relief throughout California to relieve the burden on families. The money raised goes directly to assist firefighters, those that support firefighters, and burn victims.

The R.J. Ernest Scholarship Foundation provides annual education scholarship funds to candidates in need who are members of CAL FIRE Local 2881 or their dependents with priority given to dependents of Local 2881 members who were killed in the line of duty or died from a presumptive cause.

Every time you purchase a trademarked item, you are making a difference - a portion of your money goes towards assisting these charitable causes.
