DOUGLAS COUNTY COVID-19 RESPONSE TEAM DAILY LOCAL UPDATE

(Douglas County, Ore.) – We know the public is being inundated with copious amounts of COVID-19 news, how-to tips and misleading information right now, but it is important to take a step back and focus on the primary objective; keeping people safe and saving lives. Your Douglas County COVID-19 Response Team continues to reinforce the importance of staying home as much as possible, maintaining your 6-foot people distancing, persistent hand washing, covering your coughs and taking care of yourself. The newest recommendation from the CDC suggests the use of homemade masks, as an added precaution, to aid in preventing the spread of the virus. But, make no mistake, masks are not a substitute for social distancing and do not protect you from contracting the virus. The best advice is to continue to follow the “Stay Home, Save Lives,” guidelines. Local COVID-19 Test Results

As of 12:00 PM, April 7th, 2020, there are no new cases of COVID-19 in Douglas County. The number of positive cases remains at twelve in the county, with three recovered, zero deaths and 443 negative tests for COVID-19. DPHN defines recovery as an end to all symptoms after a positive test for COVID-19.

At this time, you can only get a COVID-19 test through your healthcare provider. Residents must be identified by their health care provider, as a patient that is symptomatic, and needs to be tested. Information has been given to providers and clinics about how to get their patients signed up for the drive-through testing clinics. If you want to be tested, you must talk to your health care provider. Tests are currently being processed at the Oregon State Public Health Lab and a growing number of commercial labs, like Quest and LabCorp. There are very few outpatient clinics in Douglas County offering testing at this time. Community health partners are working very hard to make testing available to a wider number of people. The first drive thru testing site was piloted in the county on March 17, 2020, 208 people have been tested so far in the DPHN sponsored drive through clinics.

Can I visit my friends and family?

While it is certainly not illegal to go to a friend’s house at this time, we recommend that you do so only if necessary. We are not under martial law at this time in Oregon or in Douglas County. Keep in touch if you both have a phone, cell phone, computer or tablet:

- Text, message or email

Keep in touch if you or they do not have a cell phone or electronic device:

- Write a good old fashion letter and drop it in the mail
- Send them flowers, chocolates or a gift
- Have a meal delivered to them

OHA Guidance on Understanding Medicare Coverage

Oregon Health Authority (OHA) has issued guidance on understanding coronavirus-related coverage if you have Medicare. According to OHA:

- Medicare covers lab tests for COVID-19. There are no out-of-pocket costs.
- Medicare also covers all medically necessary hospitalizations. This includes if you are diagnosed with COVID-19 and might otherwise have been discharged from the hospital after an inpatient stay but instead you need to stay in the hospital under quarantine.
- If a vaccine becomes available for COVID-19 (there is no vaccine available yet), the vaccine will be covered by all Medicare Prescription Drug Plans.

OHA also issued a reminder that scammers may use the COVID-19 pandemic to try to take advantage of people, and urged individuals to treat their Medicare card like a credit card and check Medicare claims summaries for errors. If someone calls you asking for your Medicare number, hang up.

OHA Uses New Wording for ‘Distancing’

The Oregon Health Authority (OHA) announced Monday it will begin using the term “physical distancing” instead of “social distancing” to describe the practice of staying physically away from other people during COVID-19. The wording change is because OHA is emphasizing the importance of staying socially connected to family and friends while maintaining physical distance.

Social connections, which can safely occur by phone, email, social media or via video, are important to our health and wellbeing.

“Thanks for checking in on your friends and loved ones to help keep them socially connected during this time,” OHA said in a statement.

Roseburg Public Schools Launches New Website

Roseburg Public Schools unveiled its [new website](#) this week, meant to streamline online information for its schools. Each school’s website has been upgraded as well, and all contain links to the Roseburg Public Schools COVID-19 page and information on the Distance Learning for All programs, which begins April 13.
