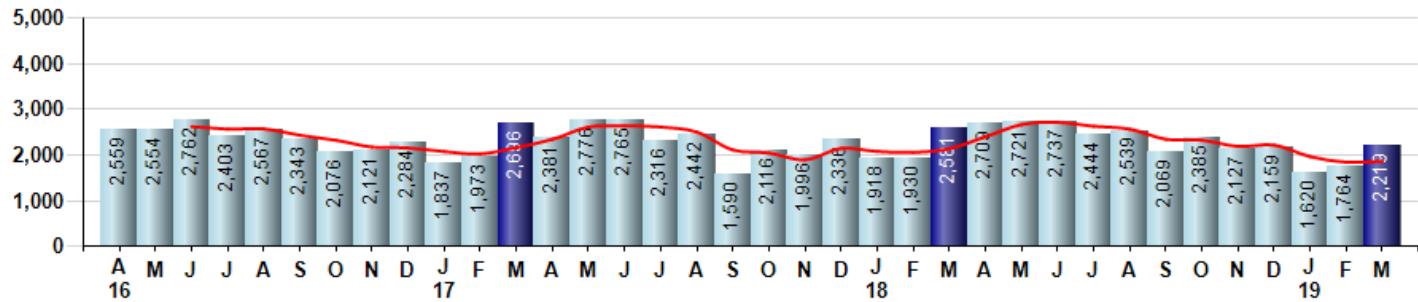

Property Sales

March Property sales were 2,219, down -14.0% from 2,581 in March of 2018 and 25.8% higher than the 1,764 sales last month. March 2019 sales were at their lowest level compared to March of 2018 and 2017. March YTD sales of 5,603 are running -12.8% behind last year's year-to-date sales of 6,429.

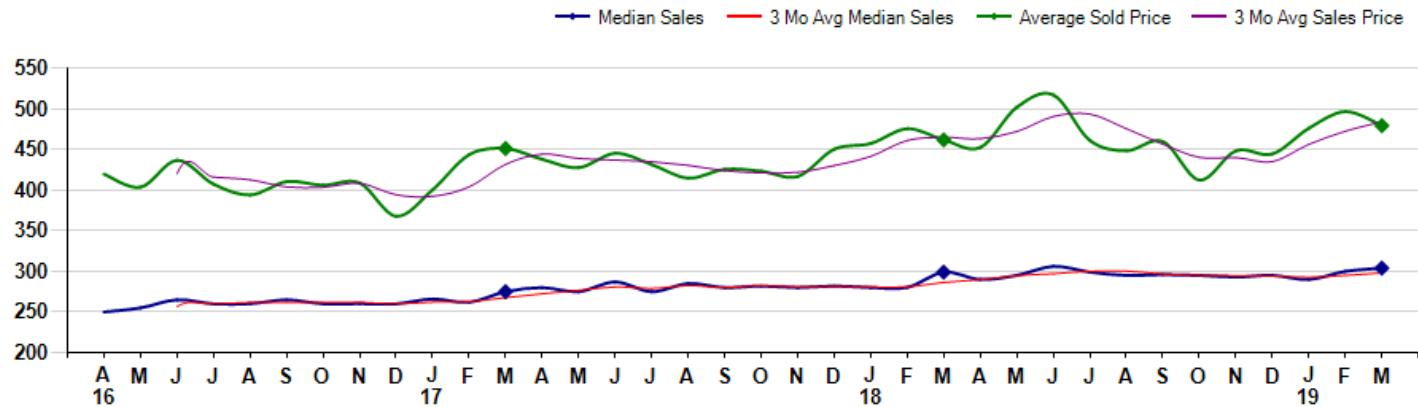

Prices

The Median Sales Price in March was \$304,000, up 1.7% from \$299,000 in March of 2018 and up 1.3% from \$300,000 last month. The Average Sales Price in March was \$479,315, up 3.8% from \$461,842 in March of 2018 and down -3.5% from \$496,702 last month. March 2019 ASP was at highest level compared to March of 2018 and 2017.

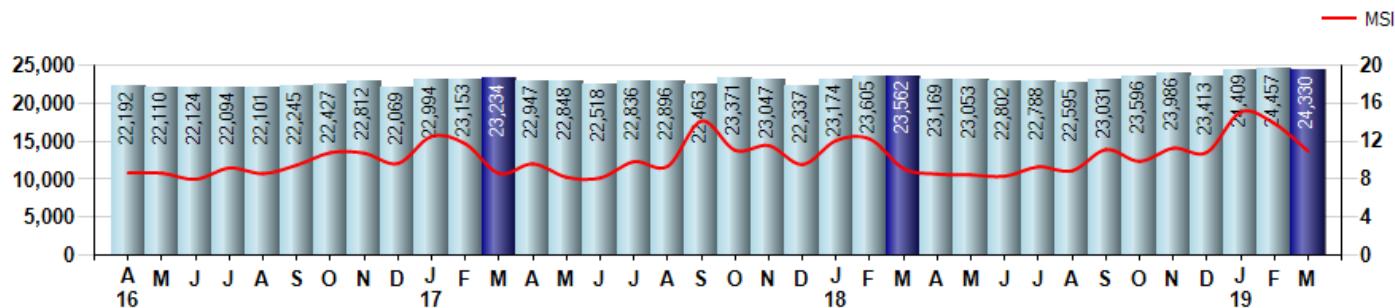

Inventory & MSI

The Total Inventory of Properties available for sale as of March was 24,330, down -0.5% from 24,457 last month and up 3.3% from 23,562 in March of last year. March 2019 Inventory was at highest level compared to March of 2018 and 2017.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The March 2019 MSI of 11.0 months was at its highest level compared with March of 2018 and 2017.

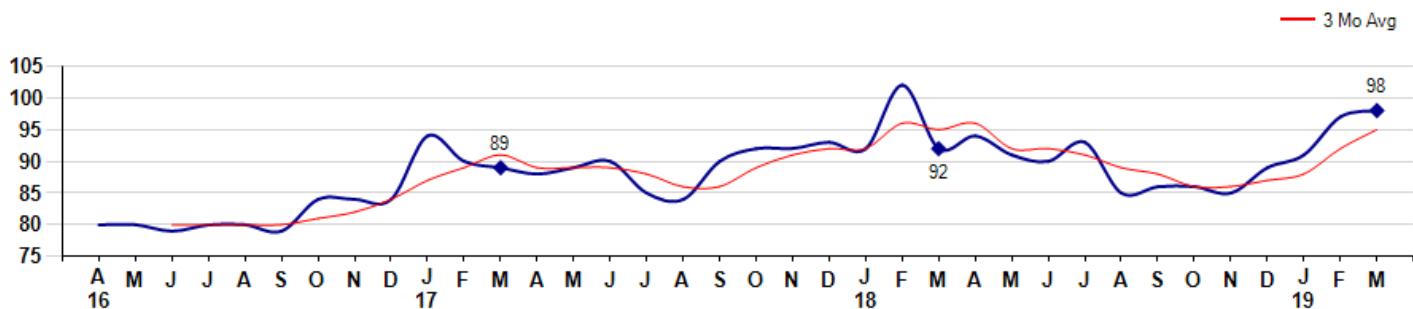
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for March was 98, up 1.0% from 97 days last month and up 6.5% from 92 days in March of last year. The March 2019 DOM was at its highest level compared with March of 2018 and 2017.

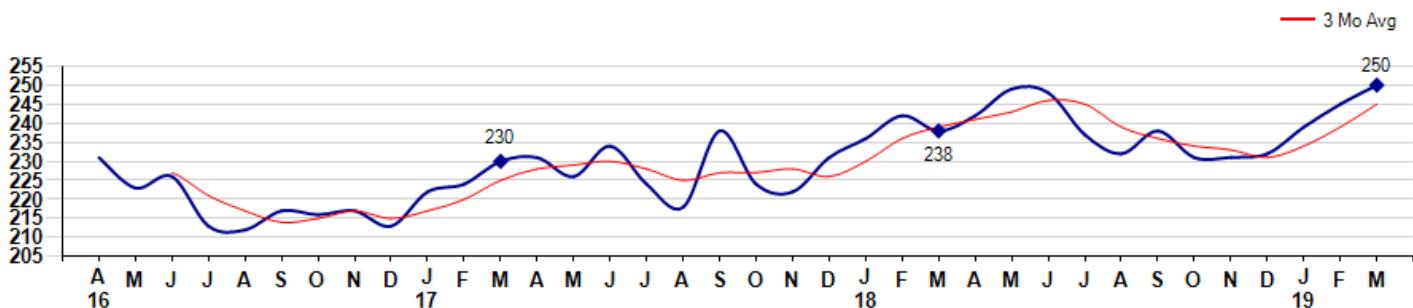
Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The March 2019 Selling Price per Square Foot of \$250 was up 2.0% from \$245 last month and up 5.0% from \$238 in March of last year.

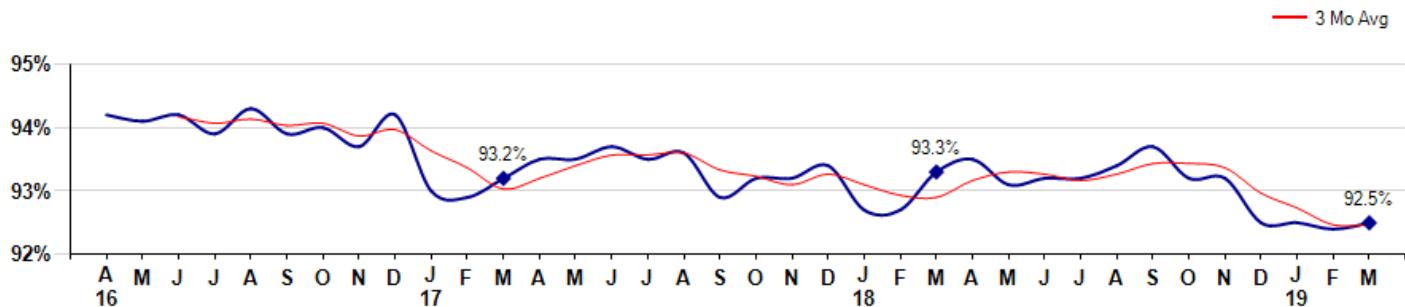

Selling Price vs Listing Price

The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The March 2019 Selling Price vs List Price of 92.5% was up from 92.4% last month and down from 93.3% in March of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in March 2019 was 4965, up 1.0% from 4,916 last month and down -2.9% from 5,115 in March of last year.
