

Whether we are developing a pandemic response plan, helping clients respond to cases, or validating the effectiveness of a client's disinfection plan, EnSafe applies safety, innovation, creativity, and discipline.

CLEANING PROTOCOL ASSESSMENTS

Under direction of one of our Certified Industrial Hygienists, EnSafe assesses cleaning and disinfection activities conducted in response to suspected SARS-CoV-2 contamination. Our assessment activities may include one or more of the following:

- Review of proposed cleaning and disinfection procedures, including comparison to CDC cleaning and disinfection recommendations
- Onsite observations of cleaning activities to determine if such activities follow established cleaning procedures
- Wipe sampling of disinfected surfaces to evaluate the effectiveness of cleaning activities. Swab samples are analyzed for the presence of SARS-CoV-2. (As an option, surface sampling may include testing for adenosine triphosphate [ATP] with a luminometer. ATP is an indicator of bacteria.)

- PPE recommendations based on task and locations
- Administrative controls regarding interaction of personnel
- Decontamination plans based on equipment, task, location, etc.
- Identifying IAQ concerns with shared HVAC systems
- Identifying "deep clean" best practices for COVID-19 affected or suspect areas
- Conformance with CDC COVID-19 prevention, containment, and response guidelines and protocols

DEVELOPMENT OF WRITTEN COVID-19 ACTION PLAN

Using information from Gap Assessment WebEx and questionnaire review, we develop a written COVID-19 Action Plan to serve as a tool for determining steps necessary to prevent, contain, and respond to COVID-19 infection, including:

- Internal & external communications
- Written policies and procedures
- Employee, Supervisor, and Visitor Training
- Routine cleaning practices
- COVID-19 Pandemic Response Plan for positive case

COVID-19 GAP ASSESSMENT

Using results from a customized questionnaire, EnSafe determines and presents gaps in current COVID-19 response policy, programs, practices through WebEx. EnSafe evaluates gaps in your facility's COVID-19 response plan. Our questionnaire is designed to gather data regarding current COVID-19 response policy, programs, and practices.
