Business as [un]Usual

Notes from the Stated Clerk about the business of the presbytery during such an unusual time as this.

Are you like me ~ a self-professed GA Junkie? A Presby-nerd? Did you logon and observe some of the Assembly sessions? Or, like me, did you logon and watch the Assembly from "gavel to gavel"? And, during this most unusual of times, this was a most unusual General Assembly. Here are some examples:

- The Assembly met entirely on-line, with Commissioners, Advisory Delegates and other participants joining the Assembly remotely.
- Extremely Abbreviated; the Assembly met over four days, instead of the more typical 10 day period.
- Only "critical business" (as defined by the Committee on the General Assembly) was addressed.
- There were no committees working on Overtures, Issues, and Statements during the Assembly.
- In fact, there were no Overtures considered by this Assembly, and all Overtures submitted to this Assembly were referred to the 225th GA.
- All actions taken by the 224th General Assembly must be ratified by the 225th General Assembly because, "technically speaking," this Assembly was not "constitutional." For more information about this, read Stated Clerk J. Herbert Nelson's Advisory Opinion, which addresses meetings of councils (sessions, presbyteries are expressly identified, but the same rationale applies to meetings of the General Assembly).
