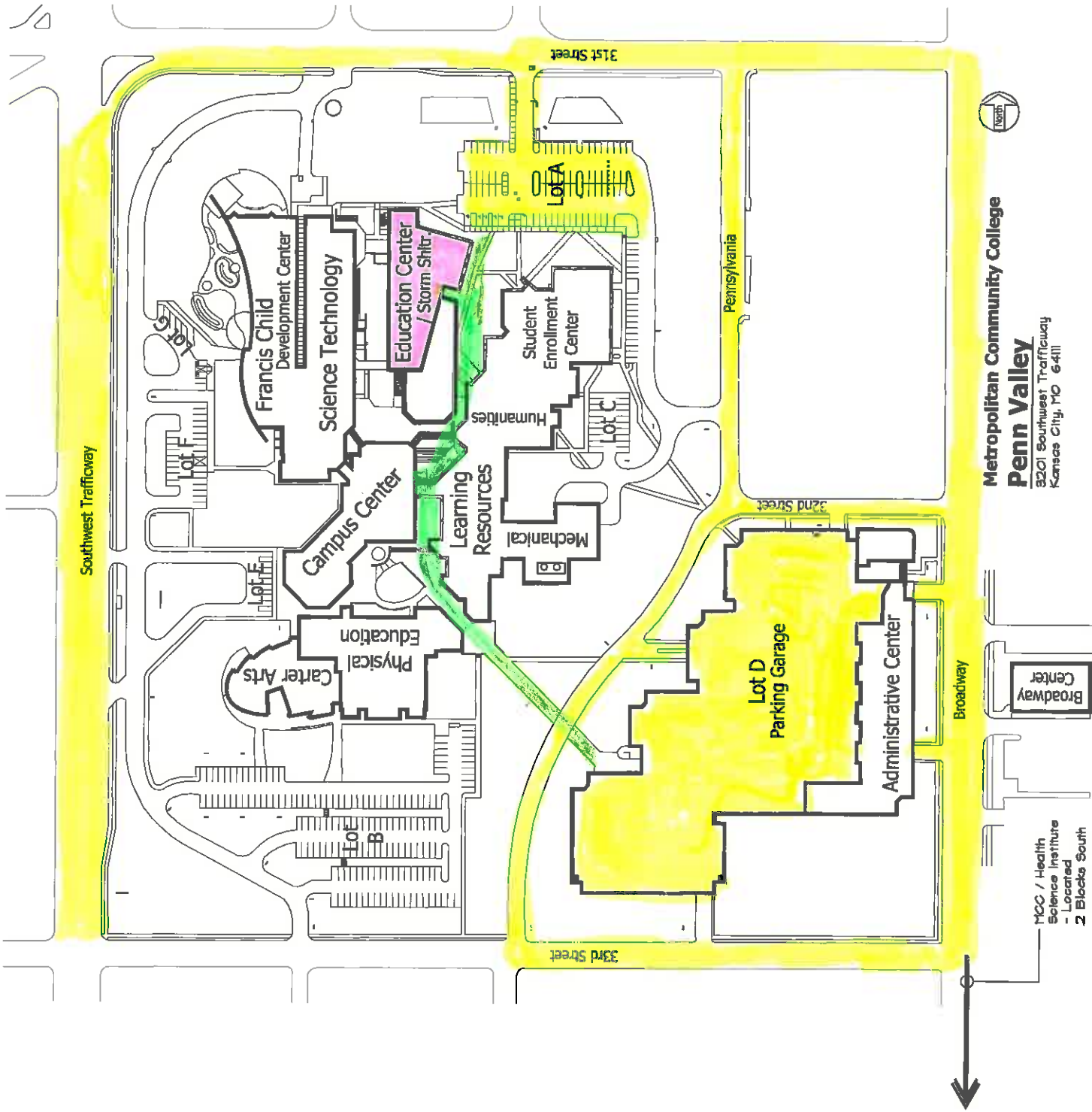

Mission: To use art creation, meditation, and mindfulness to calm the unsettled minds of veterans, first responders, and nurses with PTSD (and their caregivers) to help them better cope with their condition.

Gary Walker is a Disabled Air Force Veteran who served from 1983 to 1990 and was stationed in West Germany, was injured in the line of duty, and was awarded the Air Force Commendation and Achievement medals.

MBA, located in Kansas City, Missouri, blends art creation, meditation, and mindfulness to help veterans, first responders, and nurses find their calm and heal their unsettled minds from the devastating effects of PTSD. This is achieved through the presentation of free art and photography courses. The founders and most of the instructors – all artists in their own right – have PTSD themselves, enabling them to relate to course participants on a deep, personal level since they've been there and struggled with the same demons.

History of the Organization: MBA, a 501(c)(3) organization, was founded in January 2021. The first course was offered in June of 2021, and three courses took place that year. The organization has multiplied; twelve studies will be presented in 2022. MBA added four-week photography courses this year, three of which will take place in 2023.

MBA's art and photography courses, which have an average of 12 students each, are free for veterans, first responders, and nurses with PTSD and their "caregivers" (the VA's term for spouses and other supporters).

Jade Lawrence is a United States Army Veteran who served as an Active Duty Military Intelligence Officer. She was primarily stationed at the Army National Training Center in Fort Irwin, CA, which primarily serves as a training ground for deploying Brigades and Joint-Operations. She witnessed first-hand the impact high operational tempo can have on a service member's health and well-being. Though Jade intended to serve longer, she medically separated in 2018. Her transition to Veteran status was not easy, and the experience influenced Jade to return to school to get her Master of Social Work and license as tools to help her fellow Veterans. She sought a job at the KCVA Hospital, where she currently serves as the Transition and Patient Advocate for the **Post 9/11 Military to VA (M2VA) Integrated Case Management Program**.

Every VA medical center has a specialized Post 9/11 M2VA team that will assist Veterans in navigating the VA healthcare system and support them in achieving their health and wellness goals. The Post 9/11 M2VA team is trained in addressing the unique needs of reintegrating service members and Post 9/11 era Veterans, and they do this by:

- Collaborating with DoD and community partners to facilitate the Veteran's transition to the VA health care system
- Educating Veterans on VA eligibility, benefits, and services.
- Providing transition and reintegration assistance.
- Applying a holistic approach to care planning, including integration of Whole Health.
- Facilitating a transition of care in the event of relocation to another VA facility.
- Educating and outreach to DoD and community partners on the VA system and challenges unique to Post 9/11 era Veterans.

Workshop objective- Educate attendees on the VA's Post 9/11 Military to VA (M2VA) Integrated Case Management Program and how it can positively impact Veteran's reintegration into civilian life.

Mr. Marvin (Moe) Morris (he/him/his) serves as the Deputy Diversity & Inclusion Officer (DDIO) at the Kansas City VA Medical Center, further establishing the IDEA team within the VA.

Before employment at the KCVA, Mr. Morris was a Master Sergeant in the United States Air Force as Chief of Diagnostic Imaging, Computed Tomography, Ultrasound, and MRI. He is a trained combat medic with deployments to Afghanistan during Operation Enduring Freedom. Mr. Morris is the son of a military family with over 85 years of combined service.

While stationed in England, Mr. Morris served as president of the 48th Fighter Wing's Diversity and Inclusion Council, where his team developed the first discussion series, Finding Comfort in Discomfort, a program focused on opening lines of communication across the 5,000-plus personnel on the installation. Mr. Morris also conducted training courses for 100 supervisors on best facilitating discussions surrounding DEI. He has instructed military and civilian leaders on Cultural Competency, Implicit Bias, and Microaggressions in the workplace. Mr. Morris worked with leadership and special observance teams to produce representation plans that were funded for all observances and holidays.
