- How YOU can help those in need

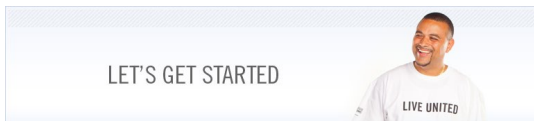

CIG Review Team Members - Now VIRTUAL!

United Way and the CIG Committee utilizes Review Team Members who are willing to help review grant applications and interview local non-profits for Community Investment Funding. You won't be alone in this process! Each member is placed on a team of 5-7 community members and given a grant application for 1-3 applying agencies.

Some members are loyal UW donors, some are first time givers and would like to see where their dollars go, some are curious about what United Way does, and others are simply wanting to make a difference! When reviewing the applications online through e-CImpact, you'll have access to their grant proposal and will submit recommendations.



These are the primary factors that help hold United Way accountable for the hundreds of thousands of dollars that are raised and allocated each year.

Strategically Investing Community Dollars

When evaluating the Agencies and their programs, there are a few main things you want to keep in mind:

1. **Are their services needed in our community?**
(Are they meeting those needs?)
2. **What are their outcomes from last year?**
(Do they project to increase impact this coming year?)
3. **Do you believe the program requesting funding will fit into the United Way model?** (Are they a good Partner?)
4. **If allocated funds, how do they plan on spending them?**
(Are they detailed about what funds will go towards?)
5. **How do their financials look?** (Are they accountable?)

Timeline for United Way of Hernando County's Community Investment Grant Process

January/February PHASE 1

The CIG Eligibility Process is opened to the community. Interested 501c3 non-profits submit the required information online to United Way prior to deadline.
(new and/or existing Partner Programs must

End of February

Qualified Programs are notified of their Eligibility and invited to attend the mandatory **Virtual CIG Agency Workshop** in March.

March to April PHASE 2

United Way hosts the mandatory **Virtual CIG Workshop for Agencies**. A walk through of the online CIG application is provided. Guidelines are discussed and Q&A.

The CIG grant process is open for two months from March to the end of April. Applications are submitted to UW thru e-CImpact by deadline. (no exceptions past deadline)

Beginning of May

CIG Review Teams will meet for a 2 hour **virtual** Workshop. Teams schedule a convenient time within the next 2 weeks for **virtual** agency interviews. (Only complete & approved applications will

May PHASE 3

Virtual Agency Interviews Take Place
All CIG Review Team evaluations and feedback are collected & viewed by the CIG Committee for further evaluation. The Committee reviews & presents recommendations

June

Executive Committee reviews & approves recommendations. They then share with the General Board of Directors for final approval.

End of June

Granted CIG Allocation amounts are announced to Partner Programs.

Monthly financial allocations begin July 1st (UW's new fiscal year)
