## Public Stakeholder Meeting Agenda

The Medical Board of California (Board) will be hosting its first quarterly Public Stakeholder Meeting on Wednesday, April 21, 2021, at 10 a.m., online through the WebEx platform and is inviting individuals, patient/consumer advocates, provider organizations, governmental agencies, and others (collectively referred to as “interested parties”) who wish to partner with the Board in support of its mission of consumer protection to attend and participate.

The goals of the Public Stakeholder Meeting include:

- Create a quarterly forum for interested parties whose mission/values align with the Board’s mission of consumer protection
- Provide an opportunity for interested parties to share their mission/values as it pertains to the Board’s consumer protection mission and offer their input with the goal of helping to improve the Board’s operations and update its policies
- Collaborate on the development of creative solutions to the challenges facing the Board
- Increase communication between the Board and interested parties

The Board requests the participation of all interested parties at this meeting. In addition to participation in this meeting, the Board requests interested parties submit an email or letter that discusses their mission/values as they relate to the Board and the goals of the Public Stakeholder Meetings. Further, the Board requests that written comments include specific procedural/policy changes for Board consideration, but must not include information related to any open licensing, complaint, or disciplinary matters that may come before the Board for a decision.

Written comments will be shared with the Board members and will help inform the topics for future Public Stakeholder Meetings. Written comments received prior to May 4, 2021 will be provided to the Board members prior to their next Board meeting on May 13-14, 2021, where Board staff will provide a report on the April 21, 2021 meeting.
