Because of that, a few of the following forms are formatted differently than you may typically see.

Complete and return these forms to Sarah or the church office, along with your \$100 deposit of cash or check. Alternatively, you may pay the deposit on Realm, but you will still need to complete these forms on paper. You are registered when ALL of those steps are completed. Registrations are due by April 10, but Early Bird Registrations, received by March 13, will receive \$20 off your final cost! The final cost will be relayed by June 1, but our goal is \$350. Youth will also need to bring about \$60 cash for food on the first and last days of the trip. The 2024 Youth Trip must be paid in full by June 30. Full or partial scholarships are available.


