

### **Patrol Highlights:**

On June 5, 2020 at 0443 hours, a suspect was reportedly swinging a knife around at the ambulance bay of Adventist Hospital. The suspect was not letting Bi-County Ambulance leave and was brandishing the knife at them. The suspect was reportedly threatening Bi-County personnel as he was brandishing the knife. Officers responded and took the suspect into custody without any victims or officers being injured.

On June 7, 2020 at 1730 hours, Officers responded to the Dollar General for a suspect that attacked and robbed the clerk. Officers quickly responded to the area and located the suspect. The suspect was booked into the jail for robbery.

On June 7, 2020, Officers responded to an individual overdosing on opiates. Officers utilized Narcan Naloxone spray which revived the victim.

On June 9, 2020, Officers arrested a suspect who was a parolee at large. The suspect was also arrested for battering his significant other and falsely imprisoning her. During the investigation it was found the suspect had sexually assaulted the victim's juvenile daughter.

On June 9, 2020, MPD Officers located a vehicle on the levee at the railroad tracks on Ellis Lake Drive. The vehicle was stolen, and the driver was arrested.

On June 16, 2020, An MPD Officer was on his way home when he observed a stolen vehicle being driven. The vehicle turned down Simpson Lane and made its way to the river bottoms. The vehicle tried to get away but got stuck in one of the deep ruts and the driver foot bailed along with the passenger. The driver fled on foot, but the passenger was located and booked on a felony warrant. The vehicle was recovered.

On June 18, 2020, an Officer was in the area of the 7-11 at 506 E 19th St and spotted an occupied stolen vehicle. The officer stopped the vehicle and was able to take the driver into custody.

On June 21, 2020, Officers located another stolen vehicle and arrested the driver.

On June 27, 2020, a stolen vehicle was located at Recology. The driver was on probation for attempted homicide. The driver was arrested for possessing the stolen vehicle.

On June 29, 2020, a suspect was fighting with residents in the 600 block of 12<sup>th</sup> Street. The suspect was swinging a large stick at people. Officers arrived and tried to detain the suspect. One officer was struck in the face trying to detain the suspect. The suspect was arrested and booked for felony resisting.

On July 28, 2020, a suspect brandished a knife and lacerated a victim. The victim was able to flee from the suspect and call the police. MPD officers searched the area and located the suspect who still had the knife in his possession. The suspect was confirmed to be on parole. The suspect was arrested and booked on several felony charges.

On August 2, 2020, Officers were involved in a pursuit with a vehicle that fled into Linda. The vehicle eventually stopped. The suspect was found to be extremely intoxicated. The driver was arrested and booked.

On August 8, 2020, Officers tried arresting a suspect for several felony warrants. The suspect actively fought officers. Officers were able to get the suspect in custody with minor injuries to the suspect and themselves.

On August 8, 2020, Officers responded to the Budget Inn Motel for a honey oil lab explosion. A couple of suspects/victims went to the hospital for chemical burns. The other suspect was contacted at the motel. The suspect was arrested and booked.

On August 15, 2020, Officers conducted a high-risk traffic stop on 2 suspects who were driving a stolen vehicle. The suspects were arrested for the stolen vehicle and several drug offenses.

On August 16, 2020, Officers responded to a male subject who was unresponsive and not breathing. Officers and fire personnel conducted CPR for approximately 25 minutes and utilized Narcan. The subject regained a pulse and was taken to ICU.

On August 31, 2020, Officers were in a vehicle pursuit which went into Yuba City. The vehicle eventually stopped, and the driver was arrested. The driver was found to be in possession of a loaded .45 caliber handgun.
