

We Draw the Lines: No Partisan Maps



Tell your representatives to put people over politics: don't rig our voting maps!

The district drawing process, known as redistricting, sets the boundaries that decide which people live in each voting district and who represents them in government. Under Florida's constitution, drawing voting maps to help any political party is illegal. Floridians made that illegal in our Constitution when we passed the Fair Districts Amendments in 2010. Any attempt to draw new voting maps before the next election in response to the President's call for gerrymandering districts nationwide to benefit Republicans is illegal in the state of Florida. It is also against the will of the people: [a majority of Floridians](#) across political parties reject both mid-decade redistricting and partisan gerrymandering.

As your constituent, I am urging you to oppose any attempt to redraw Florida's congressional map before the 2030 Census. Florida law is clear: gerrymandering for political purposes is illegal under the Florida Constitution. It undermines the foundational principles of fair representation, silences communities, prioritizes power over people, and targets Black and Latino communities in violation of their rights. Mid-decade redistricting is a direct departure from democratic norms, wastes taxpayer dollars, and would violate the Fair Districts Amendments that we the people of Florida passed in 2010. Our state's democracy works best when every person is counted and every vote counts equally. I hope you will demonstrate leadership by standing against this power grab.
