





Digital Transformation Made Simple

A Pulitzer Prize-winning cartoonist named Rube Goldberg caused my swerve toward complication. Goldberg gained fame in the early part of the 20th century when he drew hundreds of cartoons that featured zany inventions. His name became synonymous with comically over-engineered gadgets that performed simple tasks in indirect, convoluted ways.

You may have encountered some of his cartoons, like the one he used to design a self-operating napkin. His cartoons led to use of the expression "[Rube Goldberg machines](#)" to describe wacky contraptions that were overly complicated. And he is the inspiration for an annual competition known as the *Rube Goldberg Machine Contest*, which challenges participants to do simple things with decidedly un-simple methods.

Contestants – usually engineering students from prestigious universities – try to out-complicate each other while performing tasks such as turning off a light, hammering a nail, and zipping a zipper.

But while Rube Goldberg helped turn complexity into a laughing matter, little humor is found in the daunting challenge credit unions face as they consider the task of digital transformation. As I talk to credit unions, I often hear that digital transformation is one of their biggest challenges. So, I was not surprised when the Filene Institute also cited digital transformation as one of the top challenges facing the credit union industry.

In a report titled, *The Future of Digital Transformation for Credit Unions*, the author noted that 80 percent of financial industry leaders surveyed in 2020 said COVID-19 had uncovered shortcomings in their institution's digital capabilities.

With challenger banks and fintechs poised to increase their market share by appealing to consumers with frictionless, mobile convenience, how can credit unions compete, the Filene report asked.

“Many small and medium-sized credit unions, for example, are not delivering a digital experience that meets members’ expectations and have not consolidated their data, rendering it useless for increasing efficiency or personalizing service,” the report said.

“Credit unions risk losing revenue, relevance, and relationships if they cannot bring their digital service offerings up to par,” the report added.

How can that be remedied? Perhaps the answer is found in a simple tool with advanced capabilities – an anti-Rube Goldberg machine, if you will.
