#### **U.S. Department of Transportation Modernizes Hours of Service Rules to Improve Safety and Increase Flexibility for America's Truckers**

The U.S. Department of Transportation's Federal Motor Carrier Safety Administration (FMCSA) yesterday published a final rule updating hours of service (HOS) rules to increase safety on America's roadways by updating existing regulations for commercial motor vehicle (CMV) drivers.
