

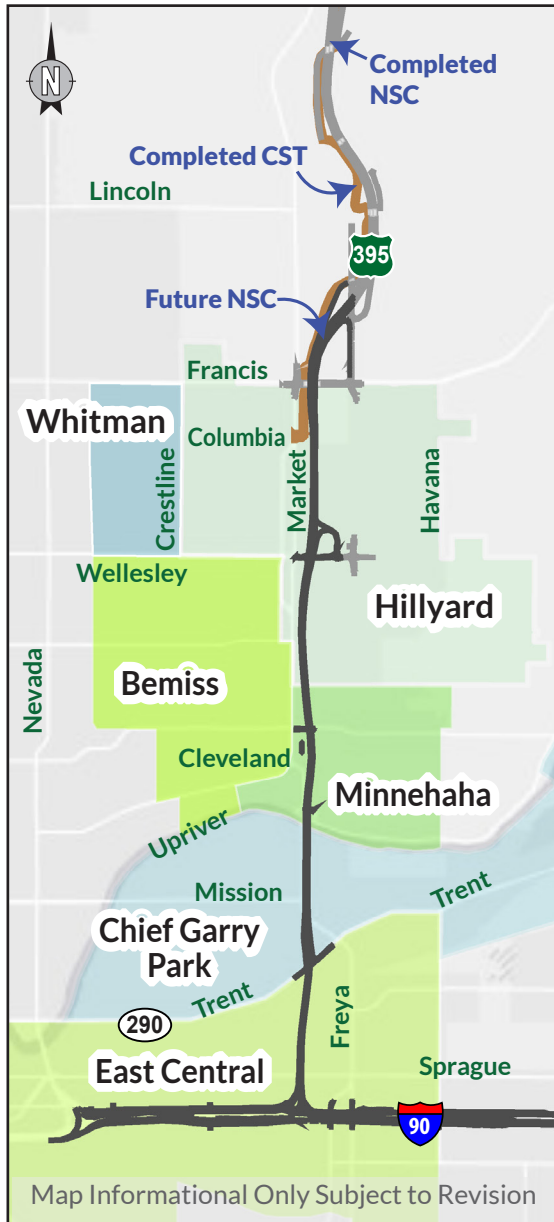
US 395 NSC "Place" Neighborhood and Children of the Sun Trail CHARRETTEs
