[Birthright Israel - Postponement of August 2020 Trips](#) -- All August trips, which were scheduled to depart from North America, have been postponed. However, Birthright is still planning to bring groups from



Austria, the Czech Republic, and Georgia. If you had a community trip scheduled to depart in August, then your partnering Trip Organizer should be in the process of reaching out to discuss what options exist moving forward.
