FOOD TRUCK FEST

Vendor space is limited. We will accept on a first come basis but reserve the right to limit due to duplication of food offerings. We will accept food trucks, trailers and 2 booths. Vendors are responsible for supplying all personal items, tents, tables, chairs and displays. All food vendors must preregister, maintain liability insurance and, if applicable, State Food Licenses and submit a copy to the Chamber.

All State, Federal and Local & Health Dept. Regulations must be adhered to. There is very limited power available. Generators are allowed. Canopies, tents, tarps and umbrellas must be securely tied down and weighted to prevent any potential injury or property damage. You are responsible for keeping & leaving your site clean. Set up is between 11am & 1pm on South side of E. Main St. There is a \$100.00 refundable deposit that will be returned after the event.

If your product requires licensing please supply the Chamber with a copy of your license. We reserve the right to limit duplication of products sold. Vendors must supply all their own tables, chairs, canopies and displays. They must be secured and weighted to prevent injury or property damage. Spaces will be assigned upon arrival. You will unload and move your vehicle before setting up. Power is not available at this event. Please do not bring pets to the market. You are responsible for keeping and leaving your site clean.

Return your registration form, certificate of liability insurance or signed waiver to the Chamber prior to the event.

This is a family friendly event. You will be asked to remove any objectionable materials. Leaving prior to the end of the event is not permitted without permission unless threatening weather is approaching.
