Dear Parent/Guardian:

As a family with a current eighth grade student, I am writing to notify you of your opportunity to enroll your child in either of our District's two (2) comprehensive high schools via "open enrollment."

"Open Enrollment" means that students who will enter grade 9 in September, 2017 and who live in the PVPUSD attendance area may choose to attend either Palos Verdes High School (PVHS) or Palos Verdes PENINSULA High School (PVPHS). Students who are presently in grade 8 must select one (1) of the two (2) schools. The form on the *reverse side* of this letter is to be used for this purpose. Planning has begun for the 2017-18 school year. Decisions on the hiring and placement of faculty and scheduling of classes need to be made. High school enrollment numbers, particularly 9th grade enrollment, are critical to effective preparation. I am asking that you read this letter carefully, discuss the options outlined on the **reverse side** with your son/daughter, and notify us of your commitment by completing and returning the form to us no later than **Friday**, **February 17, 2017**. Once you have made your choice, it will be a commitment through the end of the 2017-18 school year. Students who do not return the form by 4:30 p.m. on Friday, February 17, 2017, will be enrolled at a high school based on available space at either school.
