### Prayer and Devotion as a Session

Rev. Dr. Hylton opened the meeting with prayer and led a devotion based on the Book of Second Chronicles, Chapter Thirty-Two Verses 1 to 8. This passage describes the invasion of Judah and the attack on Jerusalem by the Assyrian king, Sennacherib, and the response of Hezekiah, the king of Judah, to these dual threats. Hezekiah prepared for the invasion with planning and organization, but more importantly encouraged his people to faithfully rely on God for deliverance from these mortal dangers. We too are facing mortal danger to our church and congregation during this pandemic; and we should make appropriate plans and take prudent action, but we must not give in to our fears, but faithfully rely on God's deliverance from COVD-19, as we serve His church and the wider community.

## Pastors' Report

Rev. Dr. Hylton reported that plans for the Chicago Presbytery meeting, which was scheduled to take place at the church on May 19, 2020, have been cancelled and that the meeting will be conducted on Zoom.

J.J. Ivaska and John Powell reported on the COVID-19 Task Force and its efforts and objectives for serving our congregation during this time of closure of the church building. Emphasis has been placed on reaching out to all of our members through the Small Group Ministry and personal telephone calls. Benevolence assistance regarding unemployment and mortgage relief issues and direct financial assistance are also being considered.

Caryl Weinberg reported on the church's efforts to provide housing at local hotels for the homeless during COVD -19.

The motion was made and seconded to approve a total gift of \$7,000 to be paid from the Mission budget (\$3,000) and the Great Commission Fund (\$4,000) to provide one week's lodging at local hotels for the homeless. The motion carried.

Rosemary Mauck led a discussion of how communication to the congregation may be improved by updating and improving the church web site to make it more timely and effective.

### **Ministry Architects Proposal**

Rev. Dr. Hylton led a discussion of the Ministry Architects proposal for additional consulting during 2020. The discussion dealt mainly with the cost of an engagement focusing on: Establishment of an Equipping Ministry, Developing a Membership Assimilation System, Establishing a Timeline and Providing Coaching for the Senior Pastor and Senior Staff.

# The motion was made and seconded to authorize engagement during 2020 with Ministry Architects at a cost of \$12,705. The motion carried.

#### **Extending Virtual Worship**

Rev. Dr. Hylton led a discussion concerning the closing of the church building and the extension of virtual worship and virtual serving of communion through the end of May.

The motion was made and seconded to extend the closing of the church building, and to approve virtual worship and the virtual serving of communion through the end of May. The motion carried.
