## **AUCTION BID BY PROXY RULES**

### **BID BY PROXY**

Bid by Proxy will take place with the participant completely filling out the Bid by Proxy form. Incomplete and/or illegible forms will be considered null and void. A representative will bid for the item on your behalf and will only bid in your place until other bidders stop.

Example: Your maximum bid is \$1,000 for an item that opens in the live auction at \$100 and increases by \$100 increments. If another bidder bids \$500, your proxy will be \$600. If all others bidders stop bidding, you'll win the item for \$600, not at your maximum bid at \$1,000.

### **BIDDING DISCLOSURE**

Suggested retail values are only a guide. Participants at the event will determine the real value of each item through the bidding. All sales are final and there will be no exchanges, refunds or substitutions

### **TAX DEDUCTIBILITY**
