Karol Corbin Walker is a partner at Kaufman Dolowich focusing her law practice on commercial litigation, business and transactional litigation, labor and employment, toxic tort, and product liability matters. Her clients have included many Fortune 500 corporations, publicly and privately – held corporations, financial institutions, entertainers, and insurance companies.

Ms. Walker has had numerous trials in state and federal courts and has argued many cases before the Appellate Division of the Superior Court of New Jersey, New Jersey Supreme Court, and U.S. Court of Appeals for the Third and Seventh Circuits. Additionally, she is a certified arbitrator and mediator for the U. S. District Court for the District of New Jersey.

With her dedication to the law, community, and volunteerism, Ms. Walker has conquered many barriers to equality during her career.

- In August 2020, she became the first person of color and first woman ever, to serve as Chair of New Jersey's delegation of the American Bar Association's Nominating Committee of its House of Delegates.
- In August 2015, Ms. Walker became the first New Jersey attorney appointed Chair of the American Bar Association's Standing Committee of the Federal Judiciary.
- In June 2015, she was elected the first African American President of the Association of the Federal Bar of New Jersey.
- In 2012, Ms. Walker became the first African American female President of the National Conference of Bar Presidents.
- In 2003, she was the first African American President elected to the New Jersey State Bar Association (NJSBA) in its then 105-year history. Ms. Walker took her oath of office before a record-breaking, standing-room-only number of attendees.
- In 1998, Ms. Walker was the first African American person appointed to Chair the NJSBA's prestigious Judicial and Prosecutorial Appointments Committee.
- In 1995, she became the first African American woman to attain Partner status at any major New Jersey law firm.

Additionally, a former Governor previously appointed Ms. Walker to the New Jersey State Ethics Commission to help ensure that State employees adhered to ethics rules. The New Jersey Supreme Court also appointed her to several committees: Judicial Evaluation; Civil Practice; Character; and Committee of the Tax Court.

KAREN M. WILLIAMS, UNITED STATES DISTRICT JUDGE FOR THE DISTRICT OF NEW JERSEY

Judge Karen McGlashan Williams is a United States District Judge for the United States District Court for the District of New Jersey, confirmed on November 1, 2021. Prior to becoming a District Judge, Judge Williams was a Magistrate Judge for the District of New Jersey from May 1, 2009 until her confirmation. Judge Williams sits in Camden, New Jersey. Since 2015, Judge Williams has co-chaired over the District of New Jersey's Reentry Court (ReNew Camden) established for select individuals on post-conviction supervision.

Before her appointment as a Magistrate Judge, Judge Williams was the managing partner of the Atlantic City office of Jasinski & Williams, P.C., a boutique law firm representing employers in all aspects of labor and employment law. Judge Williams began her law career with the law firm, then known as Jasinski & Bisceglie, as a summer associate in 1991, after spending several years in human resource management for various health care institutions. While with the firm, in addition to litigating in federal and state courts, Judge Williams developed and conducted employee training workshops on diversity, workplace harassment, wage and hour compliance, and employee discharge and discipline; conducted workplace harassment investigations; and negotiated collective bargaining agreements in both the public and private sector.

Judge Williams served as the district chair of the New Jersey Supreme Court Unauthorized Practice of Law Committee from 2008 to 2009 and was a member from 2002-2009. Judge Williams also served as the panel chair of the New Jersey Supreme Court Office of Attorney Ethics Fee Arbitration Committee in 2006 and a member of the committee from 2002-2006.

In addition to her judicial duties, Judge Williams currently serves as an adjunct professor at Rowan University in the Department of Law and Justice. Judge Williams has also served as an adjunct professor at the Rutgers School of Law-Camden, teaching e-Discovery and pretrial litigation.

Judge Williams received her Bachelor of Science from The Pennsylvania State University in 1985 and earned her law degree from Temple University School of Law in 1992.

Prior to being an AUSA, Judge Singh was an Associate at Connell Foley LLP in New Jersey and a law clerk in the U.S. District Court for the District of New Jersey as well as the New Jersey Supreme Court. Judge Singh received her B.A. from Davidson College and her J.D. from Seton Hall University School of Law.

Mr. King emphasizes his practice on civil rights and federal criminal defense. As a civil rights lawyer, Mr. King specializes in police misconduct. He has litigated numerous complex cases, both criminal and civil. He has represented families in nearly ten cases involving in-custody deaths and has obtained several multi-million dollar settlements. He was one of the lead attorneys in the “Camden Police Cases,” an 88-plaintiff consolidated civil case against the Camden Police Department and five of its officers who were indicted for falsely arresting and planting drugs on members of the Camden community. Mr. King is also actively involved in the New Jersey District Court’s re-entry program, assisting newly released former inmates in their readjustments into society.

Mr. King served as a board member of the National Police Accountability Project, a division of the National Lawyers Guild. He was appointed by the New Jersey Supreme Court to serve on New Jersey’s District IV Ethics Committee. He was also appointed and serves on the Criminal Justice Act Panel for the District Court of New Jersey. He served as Regional Vice Chairman of the Board of Directors for the Greater Philadelphia Chapter of the National Conference for Community and Justice. He also served on the Advisory Board of the Philadelphia Youth Entrepreneurial Institute. He has been a board member of the Philadelphia Sports Congress and served on the City of Philadelphia’s Football & Baseball Stadium Site Selection committee. Mr. King has been a featured speaker at Rutgers University, the University of Pennsylvania and Rowan University. He has appeared on several occasions as a guest panelist on the “Law and Crime” Network.

In 2020, Mr. King received the Mary Philbrook Public Interest Award from Rutgers University Law School for his work in the public’s interest. In 2019, he received the Judge John F. Gerry Award from the Camden County Bar Association for his contribution to the profession and the State of New Jersey. In 2018, he received the Rev. Martin Luther King, Jr. Champion of Social Justice and Equality Award, presented by Rutgers Law School’s Black Law Student Association. In 2014, Mr. King received the Gloucester County NAACP Game Changer Award for work in civil rights.

Mr. King received his B.A. from Oglethorpe University and his J.D. from Rutgers-Camden.
