

The purpose of this Request for Proposals (RFP) is to identify and select the most qualified Proponents to provide Transition to Employment Services to assist a wide range of unemployed, Employment Insurance (EI) eligible Albertans to obtain and maintain employment.

Transition to Employment Services provide comprehensive and individualized services that enable individuals to acquire workplace and occupation related skills that will facilitate their rapid attachment or re-attachment to the labour market. Services are designed to provide a variety of work-directed services which will lead to full time, paid employment.

Eligible clients will develop strategies to support their career transition and obtain an understanding of transferability of skills from one sector to another. Clients may include Albertans needing career change support, short term retraining and workforce adjustment. Clients will have access to the available services and interventions as needed, which may include individualized and group service delivery, or an appropriate combination thereof.

The Proponent is expected to define groups that need these services based on their research within the Lloydminster, Vermilion, Wainwright, Vegreville, Hinton, Edson and Jasper service areas, as well as any other rural communities in the North Region (defined as any community north of Yellowhead Highway 16) identified by the proponent.



This requirement is to establish various Regional Individual Standing Offers (RISO) for the supply, delivery and offloading of Miscellaneous Groceries, Dairy Products, Fresh Bread, Meats and Fresh Produce to the Department of National Defence, CFB WAINWRIGHT located at Denwood, Alberta on an “as required” basis during a period of one year.

The one year period is from February 1, 2018 to January 31, 2019 inclusive with one (1) rebid period at the end of year one and one (1) rebid period the end of year two. Each category will be divided into different refresh and/or rebid periods in accordance with the terms and conditions set out herein.



This requirement is to establish various Regional Individual Standing Offers (RISO) for the supply, delivery and offloading of Miscellaneous Groceries, Dairy Products, Fresh Bread, Meats and Fresh Produce to the Department of National Defence, CFB WAINWRIGHT located at Denwood, Alberta on an “as required” basis during a period of one year.

The one year period is from March 1, 2018 to February 28, 2019 inclusive with one (1) rebid period at the end of year one and one (1) rebid period at the end of year two.
