



The purpose of this RFP is to invite Vendors who demonstrate the necessary qualifications and experience, relative to the scope and nature of this project, to provide proposals for the provision of planning and design services for the execution of this project.

1. Assessment and review of the current status treatment and distribution network of the Drinking Water Systems at the 3 parks
2. Assessment and review of the current status of the Wastewater Collection and treatment systems at the 3 parks mentioned



3. Assessments should include:

- Complete inventory of all working components in the systems
- Assess remaining useful life of the Water treatment and distribution systems components including all pumps, valving and piping, water access points and current contamination prevention measures
- Assess wastewater collection and treatment systems components including all pumps, valving and piping, RV dump stations, lift stations and wastewater treatment facilities
- Conduct interviews and discussions with local staff and Regional Water & Wastewater Technologist to document any on-going infrastructure concerns and time requirements to operate all these sites
- Assess ability to isolate sections of the systems to complete repairs when components fail i.e water main breaks, sewer line breaks and/or valve or pump failures
- Review and assess current Emergency Response Plan for component failures
- Use current user statistics as basis for future growth projections and upgrades that will be required for the Parks in the next 10 years


4. Written report detailing the current status and inventory of the systems and priorities for upgrades to the systems to meet and/or exceed current regulations so as to meet incoming regulations over the next 10 years. Report should include:

- Inventory of the all the working components
- The required Lifecycle Maintenance and life remaining on the system components including replacement costs with new modern equipment
- Detailed schematics and maps of the existing systems
- Recommendations on upgrades requirements over the next 5-10 years with associated anticipated costs to ensure that the systems meet and/or exceed incoming regulations within this timeline while also leveraging new data logging and communication technologies to allow remote monitoring and reduce operator time travelling between sites
- Emergency Response Plans (ERP's) for component failures in the systems with associated risk assessments
- Recommendations on how the systems incorporate more redundancy to isolate sections of the system for repairs without impacting the whole system
- Inventory of local suppliers for replacement parts for these systems to reduce downtime
- Recommendations and a prioritized list of future upgrades to meet demand and regulations for the next 10 years

Public Services and Procurement Canada (PSPC) is requesting industry feedback regarding the Weapon Effects Simulation Modernization (WESM) procurement on behalf of the Department of National Defence.

Annex A Questions to Industry is attached to this RFI. Industry is requested to review these questions and provide answers to the PSPC Contracting Authority identified under Article 5 Contracting Authority on or before May 10, 2021.

In light of the current COVID-19 pandemic, and its impact on government operations and those of industry, please inform the Contracting Authority if you intend to submit your responses to the Annex A questions after Canada's requested response date.

Please note that the published RFI closing date is not the deadline for comments or input.

2. Background Information:

The WESM project will modernize the Canadian Army (CA) WES training system to enable individual and collective training in order to deliver combat effective CA units and formations.

The WES capability was acquired by the CA to address the deficiency in simulating realistic weapon effects during force-on-force field training exercises. The WES system provides soldiers the opportunity to train in the way that they would fight, utilizing actual weapons and vehicle platforms as they would be used in theatre and on deployments.


This capability provides data and products for effective after-action reviews to enhance the commanders' ability to train and evaluate the readiness of their troops in both an urban and rural training environment. There are four (4) instrumented static sites (with fixed exercise control center) located in Wainwright, Alberta, Gagetown, New Brunswick,

Petawawa, Ontario and Valcartier, Quebec in addition to a mobile capability which can be used anywhere within Canada, and two (2) non-instrumented sites, one located in Edmonton, Alberta and the other in Shilo, Manitoba. The intent of this project is to modernize the existing WES capability potentially addressing: equipment obsolescence; updated operational requirements; and advancements in technology and international standards (such as those being developed under UCATT). The intent of this RFI is to seek information from industry; thereby allowing the Government of Canada to better define the options for the modernization of the Canadian WES System.

3. Schedule:

Canada is finalizing the procurement schedule which will be communicated under a future RFI amendment.

Description of the Program: The Construction Program will consist of multi-trade and single trade construction projects of varying sizes and complexity.
