The Florida Department of Transportation (FDOT) will conduct a public meeting regarding the above-mentioned mobility improvement project along 36th Street, in the City of West Palm Beach. The public meeting will be held in-person and virtually, on the same date. The public meeting will have representatives available to answer questions. PROJECT PURPOSE

- To enhance pedestrian and bicyclist mobility, and improve safety along the corridor.

PROPOSED IMPROVEMENTS

- Repave 36th Street from North Australian Avenue to North Flagler Drive.
- Provide shared-use paths and sidewalks.
- Provide bicycle lanes within project limits.
- Install two new pedestrian bridges over the Carver Canal.
- Upgrade sidewalks and curb ramps to comply with Americans with Disabilities Act (ADA).
- Install pedestrian lighting within project limits.

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the effects of construction on the community.
- Temporary lane closures to build the improvements will be completed during non-peak hours.
- Pedestrian and vehicular access to all properties will always be maintained.

CONSTRUCTION INFORMATION

- Construction Start Date: Fall 2024
- Anticipated Completion: Spring 2026
- Construction Cost Estimate: \$9.0 Million

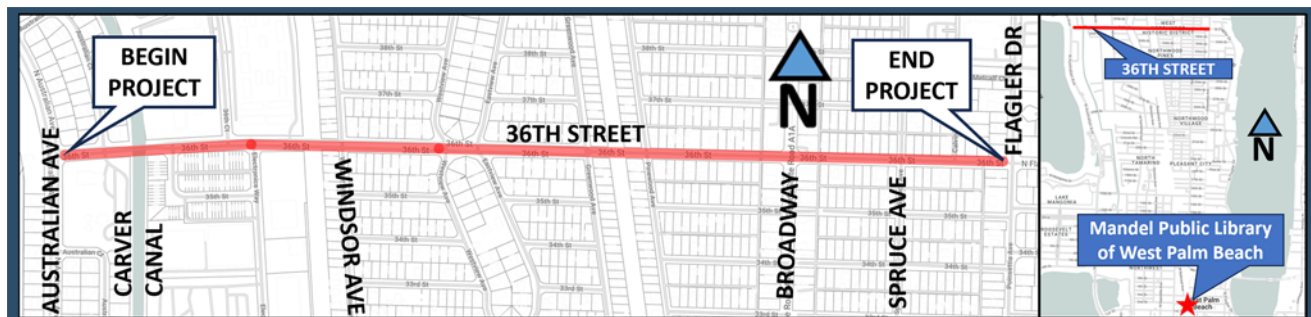
