**SR-80/US-27 Rail Crossing Rehabilitation:**

SR-80/US-27, in Palm Beach County, will have partial lane closure and vehicular traffic detoured due to a rail-road grade crossing rehabilitation from Thursday, August 8, 2024 at 7:00 a.m. to Thursday, August 15, 2024 at 7:00 p.m. If necessary to complete the work, this closure will extend to Friday, August 16, 2024, at 7:00 p.m. This will allow workers to safely perform necessary repairs to the SCFE railway at SR 80/US-27 in the city of South Bay. The work will be performed by South Central Florida Express (SCFE) contractors.

Construction Cost: \$796,848.00    Construction Start Date: August 8, 2024    Anticipated Completion: August 15, 2024

**PROJECT IMPROVEMENTS**

- Rehabilitate existing railroad track
- Replace crossing surface and paving markings to improve ride quality.

**TRAFFIC IMPACTS/DETOURS**

**SR-80/US-27, in the city of South Bay** will be impacted at the South Central Florida Express (SCFE) rail-highway crossing. During the partial lane closure, workers will rehabilitate the existing track to repair defective rails and replace the crossing surface to improve ride quality.

The following partial lane closures will be in place to facilitate traffic in the area.

**Phase 1:** August 8, 2024, 7:00 a.m. to 5:00 p.m.

- Inside lane closures set up for median demolition.
- Place temporary asphalt for crossover to be used during Phases 2 and 3.

**Phase 2:** August 8, 2024 at 5:00 p.m. to August 10, 2024 at 10:00 p.m.

- Two southbound lanes will be narrowed to one lane.
- Two northbound lanes will be narrowed to one lane and diverted to the inside southbound lane.
- Southbound traffic will be maintained in the outside southbound lane.

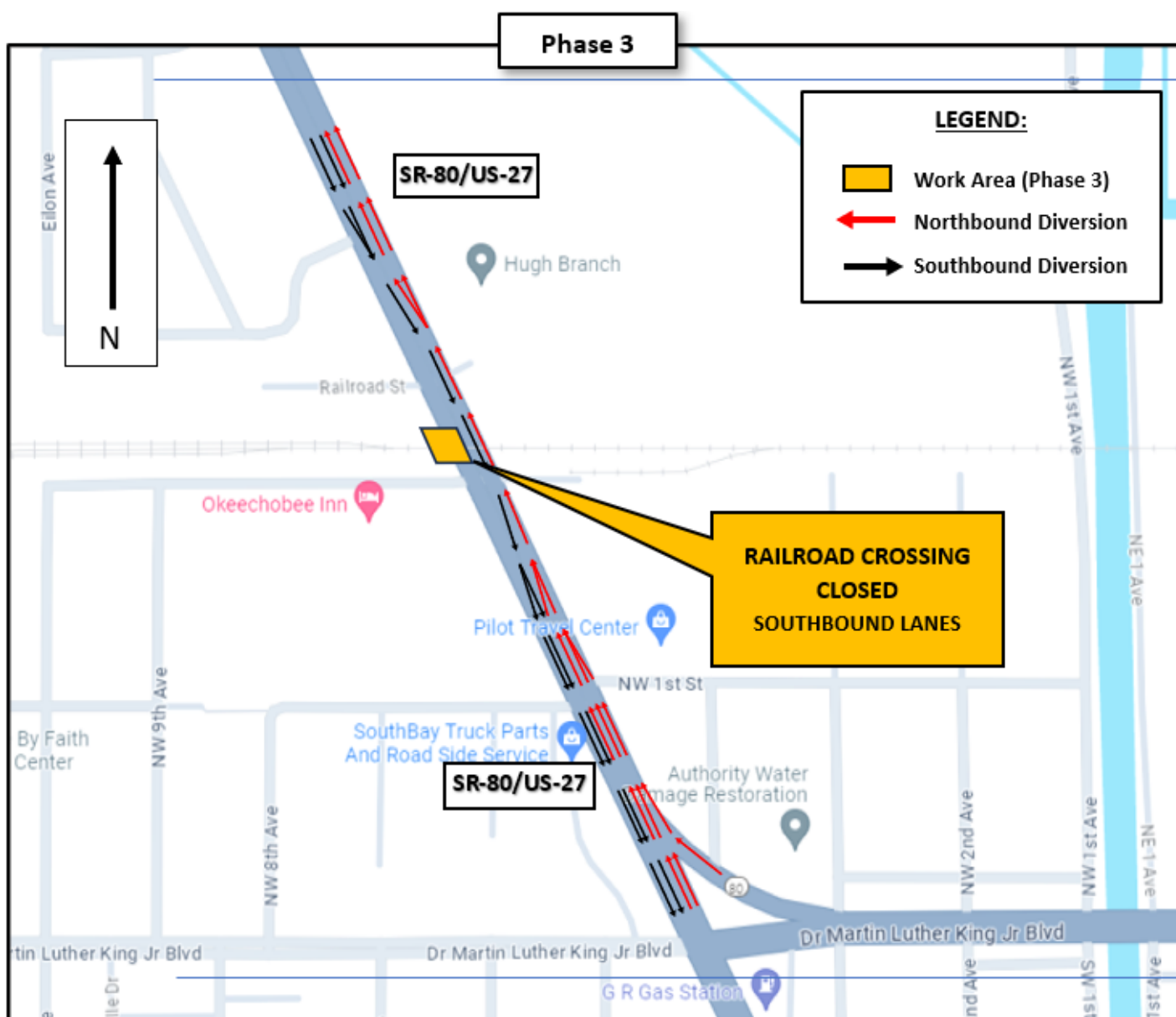

**Phase 3:** August 10, 2024 at 10:00 p.m. to August 13, 2024 at 7:00 p.m.

- Two northbound lanes will be narrowed to one lane.
- Two southbound lanes will be narrowed to one lane and diverted to the inside northbound lane.
- Northbound traffic will be maintained in the outside northbound lane.
- Southbound traffic will be maintained in the inside northbound lane.

**Phase 4:** August 13, 2024 at 7:00 p.m. to August 15, 2024 at 7:00 p.m.

- Inside lane closures set up as in Phase 1 to remove temporary asphalt and reconstruction of median.
