PROJECT PURPOSE

The purpose of this project is to increase safety by providing a new conventional roadway lighting system installed on new Florida Power & Light (FPL) poles along SR 80 from SR 15 to CR 880.

PROJECT IMPROVEMENTS

- Installation of new FPL poles for power distribution with light emitting diode (LED) lighting fixtures.
- Installation of FPL standalone street lighting poles with LED lighting.

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the inconvenience to the public.
- Lane closures will occur one lane at a time during non-peak hours to minimize impacts on traffic.
- No complete road closure will occur.

CONSTRUCTION INFORMATION

- Construction Begins: Spring 2024
- Anticipated Completion: Spring 2025
- Construction Cost Estimate: \$26,000,000




