

State Road (SR) 806/Atlantic Ave from W. of State Road (SR) 7 to east of Lyons Road
Palm Beach County, Florida

The Florida Department of Transportation (FDOT), District Four, will conduct a public meeting regarding the above project. This public meeting will be offered in two different formats: virtual and in-person. The public meeting will have representatives available to answer questions. Project information will be available for public viewing. Questions and comments may be submitted prior to the meeting by emailing the Project Manager. The virtual presentation will start at 5:30 p.m. The in-person Open House will not include a presentation and will begin at 6:30 p.m. Project information is posted at: https://www.d4fdot.com/pbfdot/future_projects_index.asp.

PROPOSED IMPROVEMENTS

- Widen from a 2-lane roadway to a 4-lane divided roadway with accommodations for future 6-lane roadway by widening to the inside reducing impacts on the public.
- 6-ft wide sidewalks and 7-ft wide buffered bicycle lanes on both sides of the roadway.
- Expanded intersection at SR 7 and SR 806/Atlantic Avenue to include a third northbound and southbound through lane and a second northbound right turn lane on SR 7.
- Expanded intersection of Lyons Road and SR 806/Atlantic Avenue to include three through lanes eastbound and westbound, dual eastbound and westbound left turn lanes and single eastbound and westbound right turn lanes on SR 806/Atlantic Avenue.
- Relocate Lake Worth Drainage District L-34 Canal to accommodate SR 806/Atlantic Avenue widening.

CONSTRUCTION IMPACTS

- Work will be performed in phases to reduce the impacts to the community
- Pedestrian detours will occur, however, existing sidewalk will remain open on one side at all times
- Access to businesses and residences will be maintained at all times during construction
- Nighttime work is expected for the repaving operations

CONSTRUCTION INFORMATION

- Construction Start Date: **Spring 2024**
- Anticipated Completion: **Fall 2027**
- Construction Cost Estimate: **\$14 million**
