

## PROJECT OVERVIEW

Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise is planning to widen the Florida's Turnpike (Turnpike) Mainline (SR 91) from north of Okeechobee Boulevard (SR 704) to south of Beeline Highway (SR 710) in Palm Beach County. The project will provide additional capacity, enhance safety, and accommodate future traffic volumes resulting from increased population in Palm Beach County.

The project covers approximately four (4) miles of the Turnpike Mainline (SR 91). The proposed improvements include widening this segment to increase the number of lanes from four (4) to eight (8) lanes.

## KEY IMPROVEMENTS

- Replacement of the Roebuck Road and 45th Street bridges
- Replacement of the bridge over M Canal
- Pavement widening
- Reconstruction
- Roadway lighting
- Signing and pavement markings
- Stormwater drainage improvements
- Noise walls in qualifying areas


