**Construction Cost:** \$7 million

**Construction Start:** September 2022

**Estimated Completion:** Winter 2024

#### PROJECT IMPROVEMENTS

- Widening, milling, and resurfacing along Military Trail and Forest Hill Boulevard
- Constructing additional right and left turn lanes on Military Trail and additional right turn lanes on Forest Hill Boulevard
- Installing new 5-foot bike lanes at various locations along Forest Hill Boulevard
- Improving sidewalks and driveways at the intersection of Military Trail and Forest Hill Boulevard
- Installing four new signal mast arms at the intersection
- Installing new signage and pavement markings

#### TRAFFIC IMPACTS

- Work will be performed in quadrants to minimize impacts to the public.
- Single lane closures are not permitted on southbound Military Trail From 7 a.m. to 9 a.m. and 3 p.m. to 8 p.m., Monday through Sunday.
- Double lane closures are not permitted on northbound Military Trail from 7 a.m. to 10 a.m., Monday through Sunday.
