The Florida Department of Transportation (FDOT), District Four, will conduct a public information meeting regarding the proposed improvements along SR 715 from north of SR 80 (MP 0.052) to south of West Canal Street South (MP 2.088) and SR 80 from SR 25/US 27 (MP 0.094) to east of Glades Glen Drive (MP 2.456) in Palm Beach County. This public meeting will be offered in two different formats: in-person and virtual, held simultaneously. The public meeting will have representatives available to answer questions. Project information will be available for public viewing. Questions and comments may be submitted prior to the meeting by emailing the Project Manager. ### PROPOSED IMPROVEMENTS

#### SR 715 from north of SR 80 to south of West Canal Street South

- Repaving the existing roadway
- Shoulder widening to provide 7-foot buffered bike lanes
- Americans with Disabilities Act (ADA) curb ramp improvements
- Signing and pavement marking improvements
- Adding 6-foot wide sidewalk on west side of State Road 715
- Adding new roadway lighting, signalization improvements, and replacing deficient guardrail segments

#### SR 80 from SR 25/US 27 to east of Glades Glen Drive

- Repaving the existing roadway
- Widening the existing paved shoulder (north side) from 4th Avenue to Glades Glen Drive
- Americans with Disabilities Act (ADA) curb ramp, signing & pavement marking and signalization improvements
- Replacing deficient guardrail segments

### PROJECT BENEFITS

#### SR 715 from north of SR 80 to south of West Canal Street South

Addition of new sidewalk (west side), buffered bike lanes, bus pads, curb ramp/crosswalk improvements at signalized intersections will provide corridor mobility and safety benefits for pedestrians/cyclists as well as area residents.

#### SR 80 from SR 25/US 27 to east of Glades Glen Drive

Increased paved shoulder width (north side), sidewalk curb ramp/crosswalk improvements at signalized intersections will provide corridor mobility and safety benefits for pedestrians/cyclists.

- Work will be performed in phases to reduce impacts to community
- Access to businesses and residences will be maintained at all times during construction
