SR A1A/S. COUNTY ROAD PHASE 2 NORTHBOUND DETOUR MAY BEGIN SEPT. 8, 2025

Beginning Monday, Sept. 8, 2025, the northbound lane and sidewalk on SR A1A/S. County Road from north of Banyan Road to south of Hammon Avenue, in the Town of Palm Beach, may be closed around-the-clock for sidewalk replacement and construction activities through approximately October 2025. **Please note this work will not begin until the northbound lane is open on SR A1A/S. County Road from S. Ocean Boulevard to just south of Banyan Road.**

Side streets within the work zone will remain open, with eastbound and westbound movements permitted on Banyan Road, Jungle Road, El Vedado Road, El Brillo Way, El Bravo Way, Via Marina, and Gulfstream Road for local traffic. A flagging operation may be utilized on side streets as needed.

Traffic will be directed as follows:

- Local traffic traveling northbound on SR A1A/S. County Road (south of Banyan Road) will be detoured on eastbound Banyan Road to access northbound S. Ocean Boulevard
- Sidewalk and pedestrian access will not be available from north of Banyan Road to south of Hammon Avenue during this time
- Side streets between Banyan Road and Hammon Avenue will remain open for east-west access with flagging operations as needed
- Southbound SR A1A/S. County Road will remain open throughout the work zone while the northbound lane is closed

- Please use caution and drive safely through the work zone at all times
- Areas closed off by barricades and signage should only be accessed by project team members
- Please follow the directional signage throughout the work zone and when flagging operations are underway
