SR 802/Lake Worth Road Roundabout Pedestrian Safety Project

The City of Lake Worth Beach, as Project Sponsor, requested that the Florida Department of Transportation (FDOT), design and construct the SR 802/Lake Worth Road Roundabout Pedestrian Safety Project, through application to the Palm Beach Transportation Planning Agency (TPA) and City of Lake Worth Beach Resolution 22-2016. FDOT is pleased to assist with completing these improvements, and will host a Virtual Public Meeting and an In-person Construction Open House on Thursday, November 9, 2023. The Virtual Public Meeting will take place from 5:00 p.m. to 6:00 p.m., with the In-person Construction Open House to follow from 6:00 p.m. to 7:00 p.m. Please see below for detailed meeting information.

Construction Cost: \$2.8 million

Construction Start: January 2024

Anticipated Completion: Summer 2024

PROJECT IMPROVEMENTS

- Mill and resurface SR 802/Lake Worth Road from Erie Street to A Street/Lucerne Avenue roundabout and Lucerne Avenue to C Street.
- Construct a six-foot wide sidewalk along the east side of Lake Osborne Drive from Griswold Drive to Erie Street.
- Install a raised crosswalk with signalization on Lucerne Avenue just east of South B Street.
- Upgrade pedestrian signals and curb ramps to meet Americans with Disabilities Act (ADA) standards.
- Upgrade lighting along SR 802/Lake Worth Road.

TRAFFIC IMPACTS

- Work will occur in phases to minimize impacts to the public.
- Single-lane closures on Lake Osborne Drive are allowed Monday through Sunday from 9:00 a.m. to 5:00 p.m.
- Pedestrian detours will be in place and flagging operations will be used to direct traffic.
- Single-lane closures on SR 802/Lake Worth Road Roundabout are permitted Monday through Sunday around the clock during active construction work. Advanced notice will be provided for nighttime detours.
- No lane closures are permitted within school zones during school drop-off/pick-up hours between 7:00 a.m. and 9:00 a.m. and 2:00 p.m. to 4:00 p.m.
- Access to businesses and residences will be maintained at all times.
