PROJECT PURPOSE

- To extend the service life of the existing pavement and improve safety along the corridor

PROPOSED IMPROVEMENTS

- Repave SR 804/Boynton Beach Boulevard from N. Congress Avenue to NW 8th Street
- Upgrade curb cut ramps to comply with the Americans with Disabilities Act (ADA)
- Upgrade signage and pavement markings
- Upgrade guardrail connections to the existing bridge

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the effects of construction to the community
- Temporary lane closures to build the improvements will be completed during non-peak hours
- Pedestrian traffic will be maintained at all times
- Access to properties adjacent to the corridor will be maintained during construction

CONSTRUCTION INFORMATION

- Construction Start Date: **January 2025**
- Anticipated Completion: **September 2025**
- Construction Cost Estimate: **\$1.2 million**
