### Lighting and Signalization Improvements Project

The Florida Department of Transportation (FDOT), District Four, is pleased to provide information for the lighting and signalization improvements project in Palm Beach County.

**Construction Cost:** \$1 million

**Construction Start:** August 11, 2022

**Estimated Completion:** Spring 2023

#### PROJECT IMPROVEMENTS

- Install new steel mast arms at the intersections of US-1/Lake Avenue and US-1/Lucerne Avenue
- Install new light poles with LED Luminaires
- Replace concrete sidewalk, driveways, and curb and gutter impacted by LED light pole installation
- Sign and pavement marking upgrades, including detectable warning surfaces
- Improve intersection street lighting and pedestrian signalization

#### TRAFFIC IMPACTS

- Construction is permitted on one corner at a time.
- Work will take place during daytime hours, Monday through Friday, 8 a.m. to 6 p.m.
- Lane closures are permitted Monday through Friday, 9 a.m. to 3 p.m.
- Access to businesses, residents, and pedestrian traffic will be maintained at all times.


