PROPOSED IMPROVEMENTS

- Adding 4-foot bicycle lanes by widening into existing medians and restriping the road
- New median sections from Silver Beach Rd. to Palmetto Dr.
- Repaving of the roadway
- Lighting retrofits from 59th Street to Silver Beach Rd. and at signalized intersections
- Barrier wall relocation at the Skypass Bridge to accommodate 10-foot shared use path

CONSTRUCTION IMPACTS

- Temporary sidewalk closures during construction
- Median access changes during construction
- One lane will remain open at all times during construction
- Lane closures may occur during non-peak hours
- Access to adjacent properties will be maintained at all times
- All work is to be done in phases to reduce impacts of construction to the community

CONSTRUCTION INFORMATION

- Construction Start Date: **Winter 2024**
- Estimated Completion Date: **Fall 2025**
- Estimated Construction Cost: **\$6.6 M**
