Play Pals is offered as a before and/or after school enrichment opportunity for all children. Play Pals meets **every day** of the week. Led by Chrystal Kracke, children can enroll for the entire session or children may "drop-in" based on enrollment. "Drop-ins" are limited and must be arranged through the Day School office the day prior to attendance. Children will experience free play in a fun environment.

Session I - Play Pals - Before School or After School - \$10.00 per hour

Session II - Play Pals - Before School or After School - \$10.00 per hour
January 10th - May 18th

Enrichment Programs do not meet when school is not in session.

Applications with fees are due before the 1st class of each program. No refunds will be given after classes have begun.

All fees for Enrichment Programs are handled separately from the regular tuition of the Day School; therefore, **separate checks** must be written for these programs. Acceptance into these programs is limited and admittance follows the priority categories as outlined in the Day School registration policy. Please note that the order in which the applications are received does not play a role in how applications are accepted.

All children should be picked up by **2:00 p.m.** following after school enrichment programs. Carpool is not held.

- 2nd tardy - The teacher will give a warning!
- 3rd tardy - Your child will no longer be eligible for enrollment in any after-school enrichment program! **NO REFUNDS WILL BE GIVEN!**
