





The coalition is a first of its kind to respond to the trajectory of Native American and Alaska Native people living away from reservations in urban places and experiencing homelessness. Ms. Echohawk will be describing the Chief Seattle Club located in Pioneer Square, in Seattle, as well as other Native homeless projects with which she is associated.
