I have been a member of the Chamber for a few years now and am familiar with the excellent programs that the Chamber provides for our many businesses and indeed all chamber members in our community.

I'm pleased to be contributing to the Advocate for the first time as your new Member of Parliament for Aurora-Oak-Ridges-Richmond Hill. I will be sharing news and highlighting programs of special interest to Aurorans. Not only is Aurora part of my constituency, it's where I live with my family.

#### THE CANADA JOBS PROGRAM

The COVID-19 pandemic has had a profound impact on young job seekers, with marginalized youth among those most disproportionately impacted. In Aurora, as across Canada, employers are also facing extraordinary challenges hiring staff. The Canada Jobs Program (CJP) can help young people find work and small businesses and not-for-profit employers rebound and grow.

Through CJP, not-for-profit employers can be reimbursed for up to 100% of the provincial/territorial minimum wage. Public and private sector employers can be reimbursed for up to 50% of the provincial/territorial minimum wage. Employees must be between the ages of 15 and 30 and work fulltime for 6 to 16 weeks. I encourage you to apply for this assistance. The deadline to apply is January 25<sup>th</sup>.

#### CEBA REPAYMENT SCHEDULE EXTENDED AND OTHER SUPPORTS

Having talked with small business owners, entrepreneurs and not-for-profits in Aurora, I know that most of you have been affected by COVID and now by the recent surge of Omicron, which is bringing renewed challenges. You have shown incredible resilience, creativity and determination. But our government recognizes you still need support and flexibility. I believe that by utilizing your resourcefulness and these supports, our businesses, entrepreneurs and communities will bounce back in new and better ways.

Repayments for the CEBA (Canada Emergency Business Account) and Regional Relief and Recovery Fund have been extended to the end of 2023. These extensions will support short-term economic recovery and offer greater repayment flexibility

This much needed breathing room is in addition to the extension of the Canada Recovery Hiring Program, the expansion of both the Local Lockdown Program and the Canada Worker Lockdown Benefit. A new Tourism and Hospitality Recovery Program and the Hardest-Hit Business Recovery Program have been launched to meet the needs of these specific sectors.
