

**PRIVATE INVESTIGATOR'S RESEARCH ON REPARATIONSBENEFITS.COM
FOR SAN FRANCISCO BLACK LED ORGANIZATIONS COALITION**

The private Investigator's research to date shows that the individuals behind the [Reparationsbenefits.com](https://reparationsbenefits.com) website have taken numerous steps to conceal their identity.

Reparationsbenefits Website and YouTube Channel

The url www.reparationsbenefits.com was registered with an anonymous registrant on October 9, 2024. An associated Youtube channel was created on December 28, 2024.

The website lists the address 12100 Wilshire Boulevard, Suite 800, Los Angeles, CA 90025. This is a "virtual office" address that functions as a mail box service for hundreds of businesses.

Businesses formed in 2024 and 2025 at this address include:

For instance, Minority Capital LLC was formed in California on February 3, 2025 and lists Garo Zoroghilian, an investment banker with Genz & Associates, as its manager. Minority Capital LLC lists its type of business as "minority investment firm." Rapid Small Claims, Inc. was formed in California on August 24, 2024 and lists Kevork Zartarian, the Chief Business Officer at ZEC International, as its officer.

Follow-up Email

Individuals that submit an application on the Reparationsbenefits.com website receive an email identifying Wonper, LLC as the company behind the solicitation with a business address of 355 S. Grand Ave, Suite 2450, Los Angeles, CA 90071.

Wonper, LLC was formed in Delaware on January 7, 2025. Delaware LLCs are not required to identify their officers and directors with the Delaware Division of Corporations, so this corporate entity allows individuals controlling the entity to not be easily identified. The company can receive legal demands through its registered agent in Delaware, which is a professional proxy service: Corporation Service Company, 251 Little Falls Drive, Wilmington, DE 19808; The registered agent telephone number is 302-636-5401.

The business address of 355 S. Grand Ave, Suite 2450, Los Angeles, CA 90071 is also a “virtual office” address that functions as a mail box service for hundreds of businesses.
