2020 Outstanding Civic Service Award Guidelines

1. Nominations will be accepted until 2pm, Friday, February 5th.
2. Nominations will be accepted from civic clubs, non-profit organizations, schools, and churches.
3. Nominations from previous years are not kept; names must be resubmitted.
4. All information and nominations become property of the chamber.
5. The Greater Iberia Chamber of Commerce Board of Directors shall select one recipient to receive the "Outstanding Civic Service" Award from the nominees.
6. The quality of civic work the nominee has performed is the deciding factor, not the quantity or number of submissions the chamber receives for the nominee.
7. Accomplishments must be outside that of the nominee's regular job or position.
8. Civic accomplishments considered are actions performed voluntarily and without pay. local, state, and national accomplishments will be recognized.
9. Nominee need not be a member of any civic club.
10. The nomination must be submitted on letter size paper (8 1/2 X 11), in the form of a typed narrative (one side only, double spaced), and please not more than four pages.
