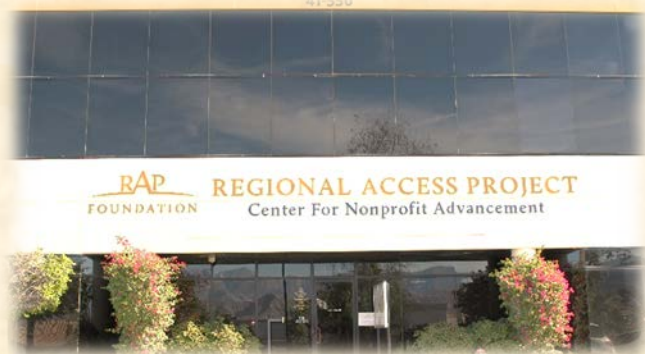

RAP is working to make our world a better place...

The Mental Health Initiative (MHI) which was due to conclude June 30, 2017 was extended for another year, owing to its **documented success in improving the quality of lives** for residents in eastern Riverside County. MHI has improved access for hard to reach and remote areas, decreased negative stigma associated with accessing services and addressed the need for prevention and early intervention services. HARC, Inc. conducted an independent evaluation which demonstrated that of the **twelve grants awarded totaling more than \$900,000 to local organizations, there were 3,195 persons directly impacted and 36,800 persons indirectly impacted.**

RAP's investment in **MHI produced a measurable reduction** in the following: **Anxiety, Depression, Mental Distress, Post-Traumatic Stress Disorder and Stigma** regarding mental health. We partnered with, for example, the Mizell Seniors Center's A Matter of Balance Program and Path of Life's Mobile Connections Program. These were only two organizations of several funded in response to our Request for Proposals process.

In addition to the Mental Health Initiative, RAP continued to provide **Small Grants up to \$5,000 throughout the year to organizations addressing our two other focus areas, Juvenile Intervention and Health:** Pueblo Unido CDC's East Coachella Valley Leadership Institute Training Program and Variety Childrens Charities of the Desert are but two examples of organizations receiving these small grants.

Also, we had several **Long Term Grants**, for example our **Partnership with Riverside County's Health Community Action Partnership's Cool and Warm Center Programs** which is provided at several community locations **throughout eastern Riverside County.**

Next, RAP sponsored **community events** addressing all three focus areas, Health, Mental Health and Juvenile Intervention. These events varied in topics but were similar in that they were educational and also provided resources to residents in the region; The Rotary Math Day and the Unforgettables' "The Child and Families in Crisis Conference" were two of the many events supported by RAP.

Lastly, we want to acknowledge the partnership with **The James Irvine Foundation** to address immigration issues affecting our local communities. In the Fall of 2017, RAP was selected as a recipient of \$200,000 Grant for the purpose of re-granting the funds to organizations addressing three key areas: Communications, Know Your Rights and Deportation Support. To date, we have allocated over \$100,000 to organizations which have the expertise and local connections to reduce the fear, anxiety and uncertainty faced by many families dealing with immigration issues.

Mental Health Initiative

Mizell Senior Center's A Matter of Balance Program

Mission: To support independence and self-sufficiency through an inclusive network of education, information and assistance with problem solving.

Addressing Unmet Need: RAP's funds allows for the Mizell Senior Center to focus on the "economically depressed, underserved communities in the eastern Coachella Valley. This highly regarded, evidence based program addresses the fear of falling utilizing a cognitive behavior change model well suited to deal with mental health disorders such as depression or phobias."

taking a hold of my life and now I have a better chance to reach my potential. I'm ready to shift from depression to being active and involved. This class is awesome!"

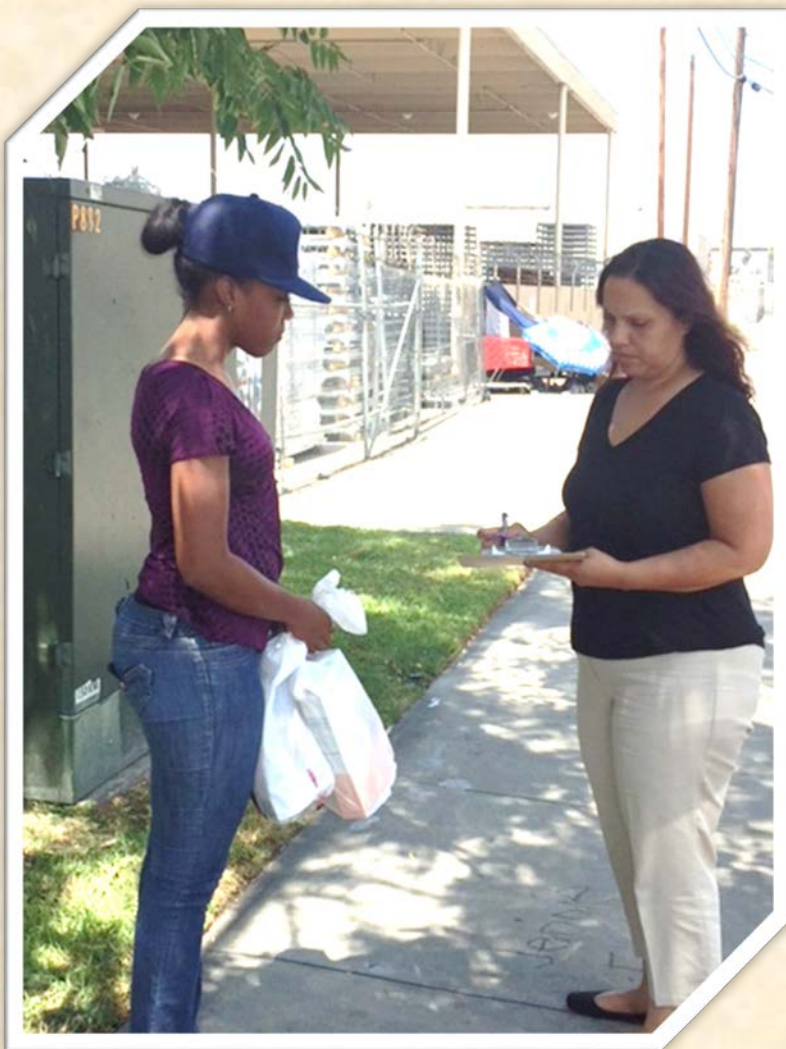
"After finishing this course, I now understand how it progressively changed my behavior and taught me to be more assertive, ask for help when I need it and to slow down when I am moving too fast."

Mental Health Initiative

Path of Life's Mobile Connections Program Addressing Homelessness

Mission Statement: Enhance the social and economic vitality of our community and people by rescuing, restoring, and rebuilding lives of the homeless.

Addressing Unmet Need: “The Mobile Connections is a project that expands the accessibility and effectiveness of mental health services to homeless individuals by literally counseling people where they are. To integrate housing and other services with partnering agencies into one seamless process for clients; helping them to develop mental health and housing stability.”



“Our population of focus, the chronic homeless encounters many disparaging needs, from lack of food, clothing, transportation issues, mental health appointments with long wait times and disproportionate resources to assist them. Providing therapeutic and social work interventions overtime amongst this population is encouraging and promising toward reducing marginalized effects of self-sufficiency, wellness and recovery.”

Small Grants -Juvenile Intervention and Health

Pueblo Unido (PU) CDC's East Coachella Valley Leadership Institute Training Program

Mission: To respond to the needs and concerns of the eastern Coachella Valley's underrepresented rural communities by actively engaging residents and fostering collaborative efforts with other stakeholders to find viable solutions, leverage critical resources, and create new opportunities to improve the quality of life.

Addressing Unmet Need: PUCDC partnered with Rural Community Assistance Corporation to develop leadership skills of residents, especially youth. The four month program uses community issues to introduce tools to help the participants seek a solutions and implement strategies.



The groups worked on a strategic plan for creating a community garden.

Participants met at the San Jose Community Center in Oasis. Classes took place Tuesday through Thursday from 4 -9 PM for a total of 12 classes.



Small Grants -Juvenile Intervention and Health

Variety Childrens Charities of the Desert's Adaptive Bikes for Children Program

Mission: To promote and protect the health and well-being of children who are underprivileged and/or have special needs in the Coachella Valley.

Addressing Unmet Need: Children with physical and mental disabilities who would otherwise not have the ability to experience the independence and recreational and therapeutic benefits of bikes. Each bike is designed to meet the physical requirements of children with conditions including cerebral palsy, spina bifida, Down syndrome, muscular dystrophy, seizure disorders and autism.

“In the summer of 2016, Ryder underwent major orthopedic surgery on his legs. He spent two months in a wheelchair casted. Once the casts came off he spent months recovering. We have tried learning how to ride a ‘normal’ bike many times. Ending with heartache and tears!” Says Briana, Ryder’s mother, “This bike is just one more amazing opportunity to build his confidence preparing him for many of life’s obstacles as well as a fun stress-free time!”

Long Term Grant in Partnership with Riverside County -Health

Community Action Partnership's (CAP) Cool and Warm Center Programs

Mission: CAP with the community facilitates opportunities towards self-sufficiency through education, wealth building, energy assistance and advocacy.

Addressing Unmet Need: Eastern Riverside communities experience extreme weather in the summer and winter months. Providing access to various locations where residents can escape the heat or cold temperatures reduces the risk of illnesses, reduces high energy cost burdens and provides awareness of resources in the community.



“Our cool center caters to a wide demographic range within the Cathedral City community. With the bus station being located right across the street, the seniors ‘let’s do lunch’ program, weekly bingo groups, and the attached senior apartment complex, we usually see a high flow of traffic. With the heat being so drastic this summer, requiring planned power outages throughout the city, and air quality being awful from the nearby fire, we’re noticing more individuals taking advantage of the center as well,” says Ron Casidine, Cathedral City Senior Center Operations Manager.

Center for Nonprofit Advancement (CNA)

RAP's CNA Program is a community resource center focused on **increasing the capacity of organizations** to be effective in identifying, addressing, and sustaining the services they work so hard to provide. CNA is charged with helping nonprofits of any size **develop the skills and acumen** they require to meet the needs of the diverse communities they serve, helping these organizations accomplish the impact they were funded to achieve.

In 2017, **CNA expanded** its consulting **services** and its training and also added mixers, mentoring and coaching components. CNA also continues to provide two **free on-line research services**, The Foundation Center and Grant Station.

CNA held its **Annual Nonprofit and Desert Fast Pitch Conference on September 28**. CNA has **revamped the popular Desert Fast Pitch competition** to include Marketing And Branding in addition to the Storytelling component, in an effort to be **more comprehensive** in preparing Nonprofits to make successful "pitches" to potential supporters.

Lastly, CNA provides **scholarships for nonprofit professionals** to earn a **Certificate in Nonprofit Management** through the University of Riverside Palm Desert Campus. In providing scholarships to these students who work with nonprofits, we are **investing in them in order to develop their leadership skills**. Students receive comprehensive training in Management, Leadership, Finance, Planning and Grant Writing over a 35 week period. For the **first time** since starting this program in 2004, CNA offered in **2017** an **Advanced Certificate in Nonprofit Management**.

More than **30 nonprofits were represented** in the two courses and 28 of the 32 students who started the program **completed it**. We along with family friends and co-workers, **celebrated their commitment and dedication** to increasing the capacity of their nonprofits.

Each year **Palm Desert Rotary honors leading educators and nonprofits** for their commitment to education. On March 27, they recognized **RAP's CNA Program** as **"Educator of the Year"**



for the commitment to provide worthwhile programs and services in building the capacity of nonprofits so they in turn can better serve their clients.

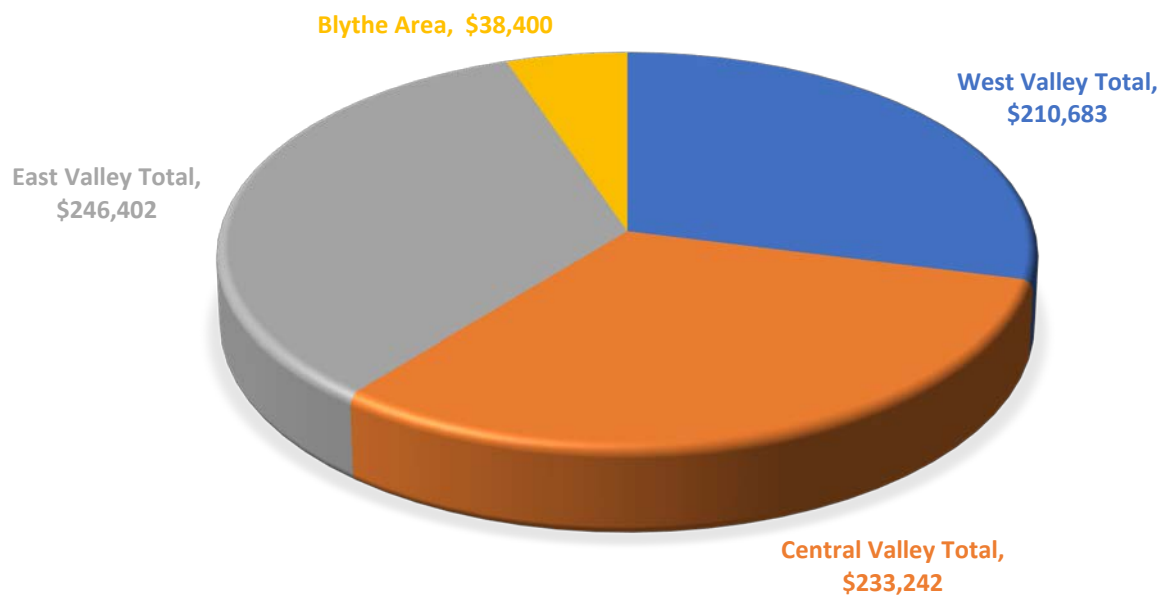

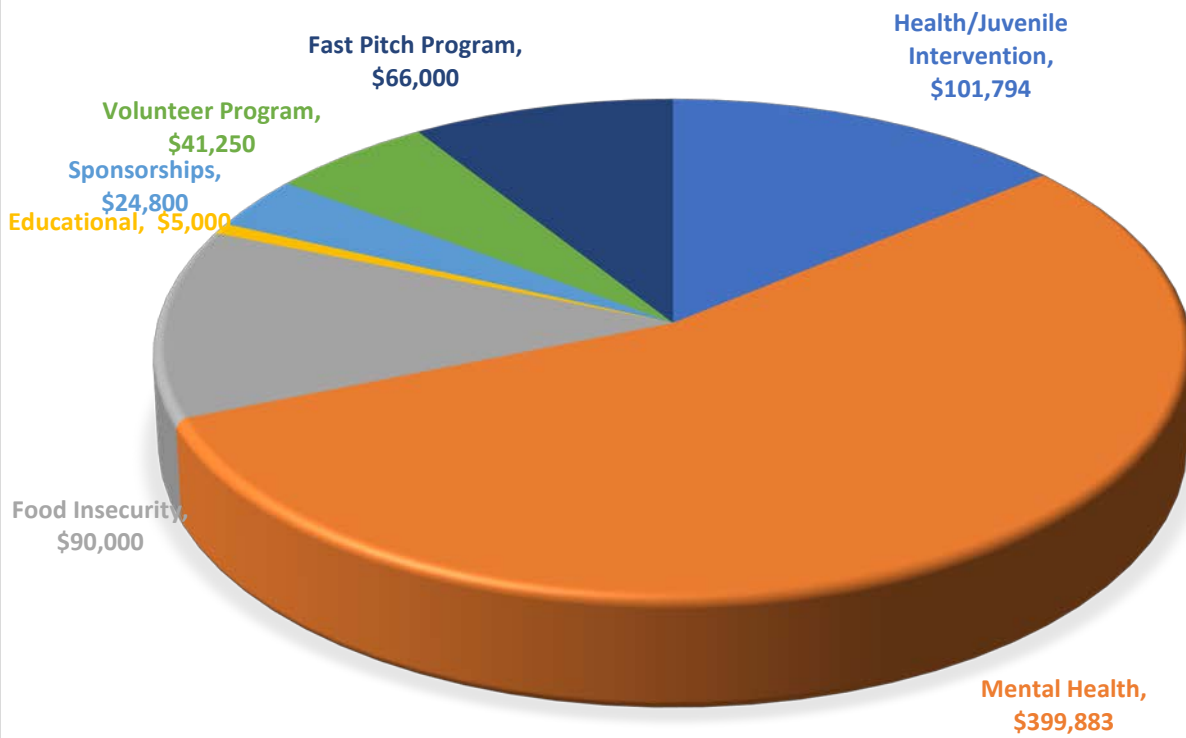
