Lawsuits

On June 23, 2022, the New York State Rifle and Pistol Association won their Landmark Case in the Supreme Court with a 6-3 decision, the majority ruled that New York's law was unconstitutional, and ruled that the ability to carry a pistol in public was a constitutional right under the second Amendment, being the most significant case in more than a decade! Decades of Right-to-Carry laws across America have proven that good men and women are not the problem. This was a monumental win for NYSRPA and gun owners across the country. And then Governor Kathy Hochul decided to break the law and pass more egregious laws assaulting gun owners, law abiding citizens, treating them as criminals further imposing on their god given rights.

Our new lawsuit **Bruen 2** is awaiting a Judge and date. Currently the Second Circuit court of appeals has 4 cases in which they have yet to decide, once that is done, we can get movement on our new case. Concealed Carry Infringement Act

Full Conceal Carry permit holders, please be aware of where you can and cannot carry. Just because you have a concealed Carry permit doesn't mean you can carry wherever you want, be aware of the laws. Check out your area and look for signs in windows, if you don't find anything posted this is NOT a place you can carry.

Ammunition

Effective September 1, 2022 Any seller of ammunition or dealer in firearms shall keep either an electronic record, or an organized structured information, or data, typically stored electronically. We keep being asked if there will be a limit on ammo purchases, if passed, ammunition purchases for "assault weapons" will be limited to two times the weapons capacity over a 120-day period, about four months. Ammunition sales for other types of guns are not restricted.

As of September 13^{th,} 2023, the New York State Police will serve as the middleman between gun owners and the FBI conducting background checks. Those checks aren't just needed for guns anymore, ammo is included.

When we hear "my vote doesn't count" you're correct, when you DON'T get out there and vote it DOESN'T COUNT! We are now in a struggle with NYS government because of the lack of gun owners voting, if we had every man & woman that owned a gun out there at the polls during the election things would not be what they are right now here in NYS! Whether you get out there and vote or not you are making an impact... with not voting your allowing this to continue.

Recently the AFT and Biden administration tried to redefine the definition of "frame or receiver" of a firearm, which has been deemed **UNLAWFUL** and called a **CONTRADICTION OF LOGIC** by the judge stating that "weapons parts kits are not weapons" In sum, there is a legal distinction between a weapon parts kit, which may be an aggregation of partially manufactured parts not subject to the agency's regulatory authority, and a "weapon" which "may readily be completed [or] assembled . . . to expel a projectile." click <u>https://www.ammoland.com/2023/07/texas-federal-court-finds-partial-frames-and-receivers-are-not-firearms/#axzz87LgyEe3y</u> to read the entire article and see the court documents.
